**Assumption of Risk and Complete Release and Waiver of Liability**

This is to certify that I, as parent or (legal guardian), am legally responsible for this participant, and I agree to DISCHARGE and RELEASE **Galaxy Skateway L.C.** from all liability arising out of or connected with my child's participation in roller-skating. In consideration of permission to use today the property, facility, and services (Facilities) of **Galaxy Skateway**, I the undersigned (Skater or spectator), hereby expressly agree:

1. To assume all risk and responsibility for any injuries I may sustain and any damages I may cause to Galaxy Skateway, its employees or any other person in conjunction with activities on the premises including anything in conjunction with equipment rented from Galaxy Skateway.
2. To release, waive, discharge and covenant not to sue Galaxy Skateway, its successors, employees, volunteers, agents, officers, directors, as well as any and all other persons, firms, corporations and companies, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned (including without limitation, injuries that may be caused from any equipment that I rent), whether caused by the negligence of the Releasees or otherwise while the undersigned is in or upon the premises of Galaxy.
3. That the undersigned participant is in adequate physical condition to participate in the events at Galaxy Skateway.
4. I authorize Galaxy to use photographs, videotapes or any other record of the events which may depict me, at their discretion, without compensation paid to me.
5. I have read the rules and regulations of Galaxy Skateway and agree to obey them. I fully understand that roller-skating is a dangerous sport and recreational activity. I acknowledge and fully understand that each skater and participant will be engaging in activities that involve the risk of serious injuries, including permanent disability and death or severe social and economic losses which might not only result from their action, inaction or negligence but the action, inaction negligence of others, the conditions of the premises or any equipment use and/or rental. Further, there may be other risks not known to us not foreseeable at this time.
6. I have current health/hospitalization insurance policy in full force and effect to cover any injuries sustained while participating in activities at Galaxy Skateway.
7. I am at least eighteen (18) years of age and have the legal capacity to enter into this waiver and release.
8. This waiver shall be valid for this visit to Galaxy Skateway.
9. Skaters may **NOT** exit the Galaxy Skateway facility at any time under **ANY** circumstances with skates on.
