

**Assumption of Risk and Complete Release and Waiver of Liability**  
**Read in Entirety Before Signing**

In consideration of being allowed to participate in any way at Galaxy Skateway, L.C., (Galaxy) its related events, and activities, the undersigned (skater and spectator) acknowledges, appreciates, and expressly agrees that:

1. The risk of injury from the activities involved in these events and activities is significant, including the potential for serious personal injuries, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury to me does exist; and,
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (as defined in paragraph 4 below) or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with and abide by the stated and customary rules, terms and conditions for participation. If I observe any unusual significant concern in my readiness for participation and/ or in the program itself or in the Skateway condition, I will remove myself from participation and bring such to the attention of Galaxy Skateway, L.C. immediately; and,
4. In accordance with Florida laws and applicable Statutes, I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify and hold harmless, Galaxy Skateway, L.C. and their employees, agents, officers, and volunteers (Releasees) from any and all claims arising out of my presence at Galaxy Skateway, L.C., including, but not limited to, claims for any and all injuries, disability, emotional injury, sickness or disease, death, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.
5. I authorize Galaxy to use any photographs, videotape or any other record of the events which may depict me, at their discretion, without compensation paid to me.
6. I will not exit the Galaxy Skateway with my skates on, at any time and under any circumstances.
7. I certify I am 18 years of age and have the legal capacity to enter into this agreement.
8. I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I also waive and release the use of my photograph or likeness for any reason or purpose.
