Justification for Real World Testing approach

Our approach to Real World Testing for the required certification criteria of b1, b2, and b6 is to request one end user export a CCDa from their practice, use direct messaging to send that to the other practice and have another end user import it into their database. We plan to have some test patients be new to Practice B and other test patients be current patients to demonstrate reconciliation as well.

Our approach to Real World Testing for the required certification criteria of g7, g8, and g9 is to request the office gather information from patients who use their chosen third party app to connect to their practice and request desired information from their record, both at a complete data level and per category.

For all criteria we will ask the practice and/or patient to report back to us the accuracy of the information provided as well as any errors encountered in the process. This information will later be analyzed and organized into the final test results report.
