Sun City Elks Support Youth Group

On Tuesday, November 14, 2017, Sun City Elks Lodge #2559 was proud to become a partner with the Maricopa County Sheriffs Youth Foundation.

The Maricopa County Youth Foundation program works with local youth from ages 14-21 years old.

The foundation works to instill discipline, respect and honor within the group and community.

The youth group works at community events providing security, assisting with toy drives for the underprivileged, helps to provide toys and bicycles to those who have none and assists with the St. Vincent De Paul charitable organization in their charitable efforts.

In 2016, the deputy's and youth group provided for approximately 4,700 toys and 700 bicycles to needy youth and plan to do the same or more in 2017 according to Deputy Merritt who is actively involved in the program.

Over the past few years, the youth group has seen nine (9) of their group go to college, two (2) become police officers, six (6) become detention officers and four (4) join the military.

The Sun City Elks assisted the program by donating a check for \$1,500 to the Sheriffs Department Youth Assistance Group Foundation, with the hope that this program will continue and grow.

The \$1,500 was a grant given to the Sun City Lodge by the Arizona State Major Project program and was provided to the Sun City Elks to assist in local youth charitable programs, such as the Sheriffs youth Program. The only restriction being the grant must be used for a program that the lodge does not presently support. The lodge already supports a boy scout and girl scout troop and a cub scout den as well as providing drug awareness and scholarship programs and students of the month programs to 12 local schools.

The Arizona State Elks Major projects program supports the Steele Memorial Foundation in Tucson, Arizona,

a foundation dedicated to erasing childhood diseases. Upwards of \$6 million dollars has been donated by the Elks major Projects Foundation, enough so that the Steele Foundation has added a new wing to their hospital naming it the "Elks Wing". It also supports a youth camp in the Sierra Anche Mountains, approximately 40 miles north of Globe. The camp is open to any organized youth group, such as school and church groups, scout groups and city and state youth groups, all expenses paid as long as these groups are organized and show proof of insurance.

The Elks Organization is a Fraternal organization and all Elk Lodges work diligently to support their individual communities.

Planed Giving

Financial Help for Grandparents Raising Grandchildren

Are there any financial assistance programs that can help grandparents who are raising their grandkids? I'm raising two grandchildren and could use some help.

Money is often an issue for the millions of U.S. grandparents who are raising their grandchildren today. To help with day-to-day expenses, there are a variety of government programs and tax benefits that can make a big difference in stretching your budget. Here's where to look for help.

Financial Assistance Programs

For starters, find out whether your family qualifies for your state's Temporary Assistance for Needy Families (TANF) program, which may include cash assistance, food stamps and free or low-cost daycare. If your household income is too high to qualify as a family, ask about the "child-only grant" for just the grandchild's support alone. You should also find out if your state offers any additional programs like guardianship subsidies, non-parent grants or kinship care.

Contact your state's TANF program (see ACF.HHS.gov/ofa for contact information) or call your county's social services office for more information about these programs.

You should also determine if your grandkids are eligible for Social Security benefits, including benefits for children, survivor benefits or Supplemental Security Income (SSI). You can find this out by visiting your local Social Security office or by calling 800-772-1213 or visit SSA.gov.

Also, check out *BenefitsCheckUp.org*, a comprehensive website that allows you to search for additional financial assistance programs or discounts that you may be eligible for, such as discounts on energy bills and prescription medications.

Tax Benefits

In addition to the financial assistance programs, there are also a number of tax benefits that may help. For example, the Dependency Exemption allows you to deduct \$4,050 for each qualifying grandchild in 2017.

There is also the Earned Income Tax Credit (EITC), which is available in 2017 to those with moderate to low incomes. The Child Tax Credit is also available in 2017 for those who earn too much money to qualify for the EITC.

If you are employed and are incurring childcare expenses, the Child and Dependent Care Credit may save you money on your 2017 return. Also, if you choose to legally adopt your grandkids, there is an Adoption Credit that provides a federal tax credit of up to \$13,570 in 2017

There are also education-related tax credits available if your grandchildren attended college in 2017. These credits include the American Opportunity Tax Credit and the Lifetime Learning Tax Credit.

To learn more about these tax benefits, call the IRS at 800-829-1040 or visit *IRS.gov*. You can also call the IRS publication line at 800-829-3676 and ask them to mail you the publications that further explain the aforementioned benefits for your 2017 tax return. Ask for publications 501, 503, 596, 970, 972. Also be aware that these credits and benefits could change in 2018 pending any tax law changes.

Health Insurance

If your grandchildren need health insurance, depending on your income level, you may be eligible for free or low-cost health insurance through your state's Medicaid Program and the Children's Health Insurance Program. See *InsureKidsNow.gov* or call 877-543-7669 for more information.

Legal Aid

You also should consider speaking to a family law attorney to discuss the pros and cons of obtaining legal guardianship, custody or adoption. Without some sort of legal custody, you may not be eligible for many of the previously listed financial assistance programs. You may also face problems with basic things like enrolling your grandchildren in school or giving a doctor permission to provide medical assistance. No child's family is ever given a bill for care at the Steele Center. The award-winning research conducted there and the care provided children there is second to none. Research is shared with childrens' hospitals throughout the world via the Internet and all donations to the Steele Children's Research Center qualify for tax-exempt status.

Our lodges are asked to have one or more events for "Major Projects" each year. Net proceeds from these events, along with our investments will allow us to contribute \$450,000 each year to "Steele" for the next five years. Every dollar collected helps to provide the necessary research and care to thousands of Arizona children each year, all without asking anything from their families.

Catalina Mountain Elks Adopt-a-Family Program


