The Applicant agrees to the following:

- 1. **DEADLINE FOR SIGN-UP IS APRIL 28th.** Application **MUST** be received by this date in order to be on the list for the first application. Late applications will be added to the list for second treatment only.
- 2. To maintain flags identifying the outer limits of the area to be treated. Flags must be in place by April 28th and kept visible until October 1st. Flags not only identify for our drivers specifically where the treatment should be applied, they also serve as a visual reminder for the blade operator of treated area. Failure to identify the treated area may result in your dust control being bladed through. Neither the county nor Jerico Services assumes any liability if your flags are not in place and visible.
- 3. Our trucks are equipped to allow us to spray the exact amount of footage ordered. Flags set longer/shorter than paid, will result in treatment short of, or longer than the flagged area.
- 4. The county reserves the right to blade the treated area if it is deemed necessary for public safety. Your road will be thoroughly bladed after October 1st in preparation for winter.
- 5. Jerico Services does not guarantee the performance of the product due to factors such as weather, surface preparation or heavy traffic patterns.
