The Applicant agrees to the following:

- 1. **DEADLINE FOR SIGN-UP IS APRIL 5TH.** Applications **MUST** be received by this date in order to be on the list for the first application. Late applications will be added to the list for second treatment only.
- 2. To maintain Jerico Services flags identifying the outer limits of the area to be treated with calcium chloride. Flags must be in place by April 14th and kept visible until October 1st Flags not only identify for our drivers specifically where the treatment should be applied, they also serve as a visual reminder for the blade operator of treated area. Failure to identify the treated area may result in your dust control being bladed through. Neither the county nor Jerico Services assumes any liability if your flags are not in place and visible.
- 3. Our trucks are equipped to allow us to spray the exact amount of footage ordered. Flags set longer/shorter than paid, will result in treatment short of, or longer than the flagged area. Your road will be thoroughly bladed after Oct. 1st in preparation for winter.
- 4. Jerico Services does not guarantee the performance of the product due to factors such as weather, surface preparation or heavy traffic patterns.

CONDITIONS OF	PERMIT:		

The application and maintenance of chemicals on crushed rock surfaced roads to control dust shall be by permit only, and in accordance with the below Grundy County Fugitive Dust Control Policy and the applicant agrees to the following conditions:

- 1. Dust control chemicals may be applied by an approved contractor and/or landowner.
- 2. Materials approved for use on the roads include calcium chloride, and lignin sulfonate.
- 3. The landowner shall be responsible for maintaining potholes and rough spots in areas applied with dust control chemicals. Should grading or blading of any dust control treated roadway become necessary by the opinion of the County due to unsafe roadway surface or weather related conditions, such grading or blading will be done by the County without notice and no refund of application costs or retreatment of surface will be made.
- 4. County Engineer's Office (319/824-6912) shall be notified 5 working days in advance of applying a dust control agent, so the roadway may be properly shaped.
- 5. Grundy County will not assume responsibility for any dust control service.
- 6. Grundy County will blade through dust control areas during the month of October to prepare road for winter, without notice to landowner.
