The undersigned Applicant requests EnviroTech Services, LLC ("ETS") to make **two** dust suppression treatments at the location noted above, in compliance with the county requirements, and agrees:

- DEADLINE FOR SIGN-UP IS** . Applications **MUST** be received by this date to receive the first treatment. **Late applications will receive the second treatment only.**
- Applicant shall measure the area to be treated accurately, and maintain flags marking the boundaries of that area. **Flags must be in place by April 15th and remain in place and visible until October 15th.** Flags not only help ETS's drivers apply treatments, they also help the County blade operator identify treated areas. Failure to maintain flagging may result in dust control being bladed through. Neither the County nor ETS assumes any liability if flags are not in place and visible. If flags are not visible, ETS may apply the treatment using reasonable judgment, or cancel the treatment.
- Applicant affirms having read the County's Dust Control Policy, and acknowledges that the County reserves the right to blade the treated area if it is deemed necessary for protecting county infrastructure or public safety.
- ETS does not guarantee the performance of the dust suppression treatments. Factors beyond ETS's reasonable control, such as weather, surface preparation, or heavy traffic patterns, can adversely affect the treatment. Treatments will not be repeated due to these factors.
- If credit card information is entered on this form, the Applicant acknowledges that ETS is not responsible for any loss of that information that occurs during transit to ETS.
