The TOHS Track & Field Boosters works diligently each year to make sure that athletes and families get all of the required information they need to be a part of this great program. So as this goes, we are required by the District to provide all of the attached documents and information that are required for athlete participation for Track & Field.

Just a quick review of the documents and sites. Please note that <u>ALL</u> documents are required to be signed and returned by or at the Parent Meetings to show <u>acknowledgement of receipt</u> of the information or to provide the needed info to us. Please read through each form. All forms will also be available at the meetings or you can *print them out and have them ready*. Please print CLEARLY.

The <u>Donation Commitment Form</u> is a direct monetary donation request allowing families to support the program and updating us how, or if you want to participate in the program. It explains the needs of the programs and options on how to donate. This donation is critical to our program. — District Document

The <u>Fundraising Commitment Form</u> is a statement of information required to be presented and what the programs needs are. Your signature acknowledges receipt of the information. District Document

The <u>Uniform Purchase Agreement (Form B)</u> – This is the acknowledgment page for ordering information for athlete uniforms and must be provided for your athlete to be able to get a uniform ordered in time for the first meet. The actual order form will **only be available at the meeting** when payment is made.

OR

The <u>Uniform Loan Agreement (Form A)</u> – This form is to request a loaner uniform for use during the season and details as to how this process is required. District Document

<u>Donation Request for Transportation Fees</u> for each athlete. The high costs of getting our athletes to the meets is substantial. We provide this transportation to over 200 athletes for each meet. This can only be done on-line. This donation is adjusted if you have an athlete participating in multiple sports.

<u>Physicals</u> - we would like to remind everyone that athlete physicals need to be completed by December 14, 2018. Donation Commitment Form

Since its inception, the Conejo Valley Unified School District and *Thousand Oaks High School* have strived to offer the most comprehensive array of enrichment programs, athletics and extracurricular activities, particularly those deemed the most valuable by our community. The TOHS Track and Field Team is pleased to offer a comprehensive and enriching educational experience to every participating student. State law requires us to provide a public education free of charge. Subject to certain exceptions, the right to a free public education means we cannot require students or their families to purchase materials, supplies, equipment or uniforms for any school activity, to pay security deposits for access, participation, materials, or equipment, or to make donations to a class, activity or program.

However, as has been explained in other documents provided to you, the TOHS Track and Field Team incurs expenses that are not covered by CVUSD. To pay for these important components of our program, we rely heavily on donations from parents and others, as well as various fundraising events. These donations directly benefit our students and make possible all of our planned activities and experiences — without this financial and logistical support from participating families we simply cannot maintain the quality program we want to continue to provide for our students. If we are unable to meet our fundraising goals, through both donations and fundraising events, it will be necessary to forego some of those activities and experiences.

Based on our planned activities and the projected costs of those activities, we are asking for a donation from each family of \$300 per athlete. This requested donation is calculated by dividing our total anticipated expenses for the year by the number of families we anticipate contributing. [This amount does not include the requested contribution for transportation.] Needless to say, we happily accept donations in excess of the requested amount!

Below we ask that you pledge your generous contribution to the TOHS Track and Field Boosters and, if possible, that you submit your donation in full along with this form. You may, if you prefer, submit some or all of your donation at a later time, but in order for us to realistically budget and plan all activities and experiences all pledged funds must be collected on or before February 15, 2020. If donations are not made in full by December 15 (when final uniform orders are due) we suggest the following schedule for donations: December 15th - \$100, Jan 15th - \$100, and Feb 15th - \$100.
