Policy for Rented Pool Facilities - Dream Big Swim Academy

This policy is in addition to the general policies agreed upon by participants upon registration with DBSA.

- A. Operational Independence: Dream Big Swim Academy (DBSA) operates independently of any facility it rents for conducting swimming lessons.
- B. Location Guarantee Disclaimer: The availability of specific locations for DBSA's activities is not guaranteed. While efforts are made to maintain consistency, DBSA reserves the right to change rental pool facilities as needed.
- C. Current Rental Facilities: As of May 2024, the rental facilities contracted by DBSA include:
- Millsop Community Center (indoors), Weirton, WV
- Home Mingo Pool (outdoors), Mingo Junction, OH
- Mingo Pool at Aracoma Park Pool (outdoors), Mingo Junction, OH
- D. Modification of Locations: Dream Big Swim Academy (DBSA) reserves the right to alter rental pool locations at its discretion, including those listed or any other venue, without prior notification or consent from participants or other involved parties.
- E. Notification: While DBSA endeavors to inform participants of any location changes in a timely manner, it is not obligated to provide advance notice.
- F. Refunds and Credits Policy: In the event of a location change, DBSA will not issue refunds or credits to participants who choose to discontinue lessons as a result. Participants are responsible for attending lessons at the designated locations following any changes.
- G. Observance of Policies: Participants are required to adhere to all policies established by DBSA as well as those set forth by the rental facilities. Failure to comply with these policies, including instructions provided by DBSA or rental staff, may result in forfeiture of lessons or dismissal from the program.
- H. Acceptance of Policy: By enrolling in DBSA's swimming lessons, participants acknowledge and accept the terms outlined in this policy regarding rented pool facilities.
- I. Dream Big Swim Academy is not responsible for pool or building closures. Rescheduling may be possible but is NOT guaranteed. If lessons cannot be rescheduled, they will be forfeited. No refunds or credits given.

- J. Inclement weather conditions such as hazardous road conditions, snowstorms, thunderstorms, lightening, etc., which result in pool closure or lesson cancellation will not be refunded or credited in any way. Rescheduling may be possible but is NOT guaranteed. If lessons cannot be rescheduled, they will be forfeited.
- K. If swimming is not possible due to thunder, lightning, or some other act beyond our control, but the facility remains open, we may do dry-land exercises, conditioning, and water safety reinforcement activities. THIS IS A LESSON. There will be no make-up lesson, refund, or account credit. If you choose to leave, the lesson shall be considered forfeited.
