

**1/27/26**

- Officers and DPW personnel responded to Hemlock Park to safeguard a damaged utility box.
- Motorists on Clinton Road and Washington Avenue were charged with driving with suspended registrations and additional traffic violations.
- Two license plates were reported lost or stolen.
- Officers responded to Nassau Boulevard for malfunctioning railroad gates.
- Officers responded to a business regarding a fire alarm activated in error.
- A victim reports he received a bill for services he did not receive.

**1/26/26**

- The Department is investigating a report of an attempted Robbery that occurred on January 26<sup>th</sup> in a rear stairwell of a Stewart Avenue apartment building. At approximately 11 a.m., a 22-year-old female victim was waiting at the bottom of a stairway to the building, waiting for her mother to open the door. At that time, a male subject grabbed her, threatened her with a knife, and demanded money. At the same time, the victim's mother opened the door to let her into the apartment building. The victim was able to break free from the suspect and enter the building. They then closed the door before the suspect could enter. The suspect then fled westbound direction towards Kellum Lane. The victim suffered no loss or injury. Garden City Officers and NCPD Canine Officers searched the area with negative results. Evidence was gathered at the scene, and camera footage from the apartments was obtained. The subject is described as a male, dark skin, 5'5", thin build, wearing all black clothing, a black hood, a red and white camouflage mask, and an Adidas cross-body bag.
- Upon investigation of a vehicle that crashed into a snowbank on Clinton Road, Officers determined that the vehicle had been stolen in Queens. Officers arrested the driver, a 26-year-old male, for possession of stolen property, unauthorized use of an auto, and driving with a suspended license.
- Officers assisted Firefighters who investigated a report of a natural gas odor on Spruce Street and deemed the area safe.
- Officers assisted Firefighters who responded to a residence for a CO Alarm and determined the cause to be a snow blower in use in close proximity to an open door.

**1/25/26**

- On 1/25 and 1/26, Officers responded to twenty-nine storm-related calls, including disabled autos, alarms, disputes, police assistance calls, aided reports, fire calls, and a wellness check.

**1/24/26**

- A person's identity was stolen and used to make a fraudulent social media account.
- Officers responded to a location for a hold-up alarm and determined that all appeared to be in order.
- The Department received a report of fraudulent activity against a victim's bank account.
- A Franklin Avenue motorist was charged with driving with a suspended registration.
- GCFD and GCPD responded to fire alarms activated by shower steam, burnt food, and system errors.
- Officers responded to a residential burglary alarm and found an open door. Upon investigation, all appeared to be in order.
- A Stewart Avenue motorist was charged with disregarding a traffic control device and driving on the wrong side of a divided roadway.
- Officers responded to a traffic light malfunction on Clinton Road.

Officers from the Nassau County Fire Marshal's Office and the NCPD Arson Squad responded to the scene. The investigation is ongoing.
