## **Scholarship Allocation**

A limited number of scholarships are available for a representative of a current full Member Organisation of ILGA located in Pacific Island nations to attend the meeting.

Priority will be given to active member organisations of ILGA, especially those which have contributed to the regional and / or international work of ILGA.

Scholarships can cover all or some of the costs of attending the meeting. In your application please indicate what costs, if any, can be paid for by your organisation. Scholarship funding can be used to cover the costs of:

- 1) Registration Fee ILGA Oceania Meeting
- 2) Return economy travel from your closest airport
- 3) Accommodation in the host city while attending the ILGA Oceania conference.
- 4) Meal Allowance to cover breakfast and dinner while attending the ILGA Oceania conference.
- 5) Transport from and to the airport.

#### **Air Travel & Accommodation Policy**

All travel and accommodation will be arranged by ILGA Oceania. Travel arranged by you will not be reimbursed by ILGA Oceania. ILGA Oceania will pay for the cheapest return economy fare from your closest airport to the conference or your accommodation. While your airline preferences will try to be accommodated, ILGA reserves the right to book flights on another airline to obtain a cheaper fare. ILGA will book and pay for accommodation and breakfasts for the conference. All other expenses, e.g. phone, mini bar, internet, must be paid by the scholarship recipient. Additional accommodation and breakfast will only be provided if there is a need to travel the night before in order to arrive in time for the start of the ILGA Oceania conference or return travel is not possible on the Friday evening after the conference. Once the reservations have been made, any changes to travel or accommodations must be done through ILGA Oceania.

Scholarship application forms must be completed by the person wishing to attend the meeting and must be signed by an "Authorising Person" in the ILGA member organization, indicating the applicant is representing that organisation. Nominations must be submitted by the due deadline, unless an extension is granted. All applicants will be informed of the outcome of their application.

## **Privacy Statement**

We will only use this information to assess whether to give you a scholarship and it will not be passed on to third parties.

#### **Visitor Visa**

Applicants are responsible for organising their own visitor visa for the host country. However, if you require help, let a member of the ILGA Oceania board representative know you are having difficulty. This visa application process should be done promptly in order to ensure a successful applicant can attend the conference.

## **Conference Participation**

The participants funded by scholarships are expected to take active and full part in the conference program. Reimbursements will be made based on registered attendance. If the participant fails to take part in at least 75% of the conference program, ILGA reserves the right to not reimburse the participant's travel costs.

In accepting the scholarship, participants will be asked to formally agree to all the above. Failure to agree to the conditions of the scholarship will result in the withdrawal of the scholarship.
