George Lowe wanted to know where we buy pumps. Dan responded that he purchases them from Grainger and that he gets them at a very reasonable price. George also wanted to know about the Right to know conversation Dan had with our attorney. We were advised to not produce documents that we do not have, so we will be sending the collections report to George.

Ralph Rudy asked if the original contracts between property owners and the borough have been found yet. This document is said to state that the sewer rates won't go up past \$43.00. Dan and Barry will look for them. Ralph also gave Dan the contact information for Alan Zeigler, an engineer who can provide us with recommendations for the Sewer Plant. Alan is also making himself available to look into grants as well.

Adam reported a busy month at the sewer plant. He had to contend with clogged pumps, failing floats, setting up the sampler, and replacing a failed motor on one of the pumps.
