# **Sewage/Sewage Authority Report**

Adam Pavusik reported that the sewer plant had a relatively good month. The only issues were baby wipes had once again clogged pumps 1, 2, and 3. In addition, there was a high level of solids due to the fluctuation in the air temperature. Adam had resolved these issues at the plant and will keep a close eye on the coliform levels. Also, a service kit was ordered for the generator. The grass has been cut at the sewer plant but no weed whacking had been done.

## **Sewer Solicitor – Dennis Shatto**

Dan presented the board with the Ordinance to change the monthly sewer rates from \$63.00 per edu to \$100.00 per edu.

Upon motion of Kim Balthaser, seconded by Michelle Shutt, the new sewer rate will be advertised on the borough's website, in the Duncannon Record, and on Blue Ridge's cable network. All in favor, none opposed.

Dennis Shatto has advised us to not give Nikolaos and Angela Mavropoulos a reduction in their sewer rate.

The final adoption of the new ordinance to increase the sewer rate will occur at the July 13<sup>th</sup>, 2015 meeting.
