# 5. Reports of Commissioners

- a. Road Commissioner.
  - i. Fairview is breaking up again. A quote was requested for pothole filling.
  - ii. 32 Bank Street has a runoff issue. We are likely responsible. A quote is also being requested.
  - iii. It looks like grants may be getting put off for another year. James Warren has inquired about a definitive answer on the matter, but he hasn't been able to get a definitive answer.
- b. Tree Commissioner.
  - i. The tree of concern on Fairview was removed.
- c. Parks and Sidewalks Commissioner.
  - i. No report was given, but the bench has been placed on the center island. James Warren suggested July 4th or Donna's birthday for the date of the ceremony.
- d. Police Commissioner.
  - i. There were 95 hours logged by Officer Corey. 10 tickets were administered. \$1800 in fines. 46 house checks.
  - li. Across from Susan Borden's access on Bank Street, there was some gravel brought in from the town to help facilitate a spot for Officer Corey's vehicle.
  - lii. An estimate for removing rust from the fender of the police vehicle was given. The estimate was for \$500.
- e. Treasurer.
  - i. We need a new set of signatures for the passalong of warrants. James Gallen will be inquiring about a signature card for the Bank of Bennington. Kathy will be looking into changing the signatures at Heritage.
  - ii. The house at 11 West road has had their property taxes paid three times. The second two payments have been returned.
  - iii. The Banner ads have been paid for.
  - iv. The bill for the cleanup by Pembroke has increased by almost 50%. We will be paying it but we will have to look at getting additional bids.
  - v. We received \$680 in highway fines.
