4. Reports

a. Road

- Same as always: A lot of money for winter maintenance, roads are falling apart
- Focus on Fairview repair- have enough in reserves (\$270,000) for replacement but also looking into loans
- Cooperative agreement with the police department could be a model for road maintenance.
- Resident comments: Is there political help?, Can the speed limit be lowered?, 'hydrologically connected road' segment has been thoroughly investigated and denied, is there a liability issue with the condition of Fairview?

b. Police

- Officer Corey & cruiser retirement
- Residents can request property check from Bennington Police
- Planning on fewer hours worked with greater efficiency
- More detailed reporting & data available
- Resident comments: speeding on Bank & Catamount, Church St intersection, unlocked car rummaging

c. Tree

- Village is primarily responsible for trees in central islands
- Clearing around Walloomsac Inn
- Resident comments: new tree planting program, adopt-a-tree idea for Monument Ave

d. Parks

- Email trustee with streetlight & sidewalk issues
- Goal of renovating meeting house marker as part of Vermont 250th anniversary committee (\$50-75,000)
- Resident Comments: bravo for the efforts, condition of marble sidewalks, no Church Lane street light

e. Auditor

Not present

- f. Treasurer
 - 2023 Income higher than anticipated (COVID)
 - \$42,000 2023 income variance (under budget)-didn't buy police car
 - Salt & plowing 50% over budget- cost increases
 - \$68,392 transfer to reserves for the year

6. Budget

- No tax increase proposed
- No ARPA or cruiser sale next year
- Hoping to increase highway fines
- See full budget in annual report
