

Board of Directors Meeting Minutes Wednesday, April 21st, 2021 @ 7:00 – 8:00 pm hours Via Zoom Calgary, AB

1. Call to Order

Terry Chelich called the meeting to order at 7:02 pm.

2. Attendance & Quorum

3. Approval of the Agenda/Any Additional Items

8.2 Terry reviewed the benefit of installing "owls" on the roof to deter woodpeckers. Will wait to see what activity we "hear" this year prior to proceeding.

8.3 CEBA application is still outstanding.

8.4 Linda will talk to Karyn to see if she wished to replace her front garden bed with planters.

8.5 There will be no tree trimming this year. Linda will emphasize in the next newsletter.

8.7 It was moved by Terry and seconded by Cathy that Linda will find a contractor to fix the drywall in the shed. It was moved by Terry and seconded by Linda that Terry will contact Joel at Time Savers to fix the grass at the corner of Signal Hill Heights and Signal Hill Circle.

8.9 Linda supplied a list of owners who aren't paying by Interac so the transaction fees are being borne by SHV. Linda will contact those owners and request cheques which cost SHV nothing to transact.



8.10 Terry will contact Steve at AutoRain to start up the sprinkler system and Joel at TimeSavers to perform spring cleanup.

8.11 It was decided to not pursue the insurance claim from the flood any further. Closed.

8.12 Linda will follow up with Telus when they might be installing the fibre optic lines since that may impact any outdoor concrete or lane repairs.

8.13 Linda will obtain quotes to fix Signal Hill Lane and the B unit garage pads, since water is beginning to enter B unit garages.

8.14 Linda will send out a community newsletter.

8.15 It was moved by Terry and seconded by Cathy that Linda will buy fertilizer and perform spring fertiliizing of the lawns. Carried.
