

#### From the desk of the web site committee

We are planning to have an additional page on our website, with a Button - for the purpose of collecting donations for our organization.

Given the fact that sometimes members or donors do not have a checkbook or cash available, or do not have the time to mail in checks, it will be easier to donate with a click of a button on our website.

We have searched around for the best rate available, considering the most reliable and trustworthy software company on the market today. We find that SQUARE is a good choice, given its reputation, and because their rates are better for what we need, for each transaction:

Square charges <u>2.6% + \$0.10</u> PayPal charges 2.89% + \$0.59

We learned that ANKH Court #92 already has an account with Square, so it appears that the best and guickest solution is to use SQUARE.

All donations will go directly to the Bank Account which the Treasurer oversees.

We may also have an option, to put another specific Button on the Website, for the purpose of payment of the dues from members only; <u>again</u>, <u>all the monies would be deposited in the Bank Account that only the Treasurer and authorized officers oversee.</u>

If another fundraising project arises and it is necessary, we may put an additional Button for the specific purpose. Keep in mind that all the monies will be deposited in the <u>Bank Account specified</u> and controlled by the treasurer.

We met at the SJMC on June 5th. Jr PHP Lady Cathy Rogers and Lady Carol Bish helped to cut and prepare 8 tie blankets for PHP Lady Susan Logan to tie for us. PHP Lady Vicky Cooley is sewing many pairs of shorts and I am finishing up Quilts and Pillowcases. These items were taken and donated to the Hospital during the GHP Visit. There was a total of 110 items donated this year so far.

The sewing committee donated to the Sacramento Shriners Children's Hospital 20 pillowcases, 9 quilts, 14 tie blankets in total and 67 pairs of shorts for a total of 110 items.

We also donated 14 pairs of shorts to the Honolulu Shriners Children's Hospital per the request of Lady Thelma Lam HP, Hawaiian Court (thank you Lady Cathy Rogers, JPH for the contact information). We voted on this philanthropy motion in our Court and it was approved. It's not much but every little bit helps. They don't have a sewing committee and the Hospital was needing shorts so I sent what we had on hand at the time which was before the horrific fire on Maui. That hospital is in need of hospital gowns we were told. We received a letter from Shriners Hospitals thanking us for our donation. This is philanthropy among our Courts to help other Courts and Hospitals for Shriners Children.

Thank you very much Ladies for all your efforts to support our Shriners Children's Hospital as this is our Mission.

If anyone is interested in donating fabrics such as Cotton, flannel or fleece, we would very much appreciate it. The cost of fabrics is very high due to the Pandemic.
