

Trash Talkers is a project committed to beautification in the Ohio Valley by providing clean-up services to people experiencing homelessness in Wheeling. They offer donation-based services for community members. Trash Talkers mobilizes volunteers to reinvest in the local community needs by providing lawn mowing, landscaping, and odd jobs for people in need. They focus heavily on waste reduction by recycling, repurposing, and up-cycling.

Kate is also the facilitator of House of Hagar Catholic Worker community that is dedicated to serving people in need in Wheeling, WV. House of Hagar is dedicated to building up the local community through companionship with people on the margins and by providing volunteer opportunities to engage with social justice issues.

In his time as VP and President of the Ohio County Virtual Lions Club, Matt alongside his father helped to launch a plastic recycling program through Trex. community members with cleaning out their homes and increasing access to proper waste disposal to people who otherwise, could not do so. Another large part of the program is recycling. Paula and her crew have been found in the creeks removing dumped appliances, picking up cans from the streets, and taking calls from the community to pick up unwanted scrap metal for recycling. Trash Talkers feel recycling is important.

When Paula is not busy as the "trash queen" she can be found spending time with her granddaughters and family in Martins Ferry enjoying a nice bonfire with s'mores or at competitive dance competitions.

Terri introduced the current one day a week four hour drop off recycling program which has proven to be very successful with it growing from the first year of 116,000 pounds to a high of 386,000 pounds pre COVID.

Terri was instrumental in getting recycling introduced in Wetzel County schools. Various other activities have been introduced since 2012 including the current summer litter cleanup program

which is a group effort with five different agencies all working together to clean up Wetzel County and providing educational information to various groups in the community. Wetzel County SWA just recently started their monthly tire collection.
