



# AWVSWA 2024 Scholarship

## AWVSWA SCHOLARSHIP AWARD APPLICATION INSTRUCTIONS

### I. Important Dates

- **April 1:** All completed application forms and documentation must be received by the AWVSWA Scholarship Chairperson. A teleconference call/interview may be scheduled with the applicant upon receipt of completed application.
- **April 17:** Committee recommendation forwarded to AWVSWA Board for review.
- **May 1:** Announcement of Scholarship winner(s).

### II. Scholarship Awards

**A. Eligibility:** AWVSWA pledges to uphold the policy that all persons shall have equal access to this program, regardless of race, color, age, gender, marital status, creed, religion, or disability.

- To be considered for an award, the candidate must be the (a) employee, (b) SWA volunteer with documented volunteer hours, (c) child, or (d) grandchild of an AWVSWA Member (hereon known as sponsor) in good standing at the time of their recommendation and the award selection. It is the responsibility of the sponsor to inform the local SWA board that they are sponsoring an applicant.
- Applicants must be (a) graduating high school seniors, (b) graduate equivalent certified candidates, or (c) currently enrolled in an institution of higher learning AND accepted for enrollment in a (a) junior college, (b) four-year college or university in an undergraduate program, or (c) an accredited trade school.
- Preference will be given to those studying environmental programs.

### B. Awards

- When possible, consideration may be given to awarding the applicants in a method that represents the entire membership area.
- The amount of the scholarship could vary depending on (a) the number of qualified applicants and (b) the funds that have been approved for the year.
- If no applications are received, or a lack of qualified submissions, are received, the AWVSWA Scholarship Committee reserves the right to carry over the designated monies to the subsequent year's scholarship funds.

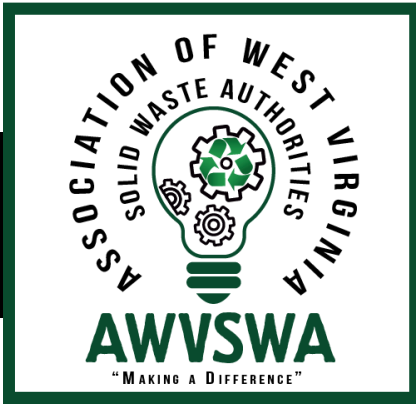

## III. Completing the Application

- Each applicant will be required to submit the following by the April 1st deadline to the AWVSWA Scholarship Chairperson:
  - Completed application form
  - A letter from the applicant discussing environmental issues/solutions
  - A letter of recommendation from a school official on school letterhead
  - Acceptance letter/certificate to an accredited institution of higher learning\*
- Completed applications must be received by April 1, 2024 and can be either emailed or mailed via USPS

  - Mailed USPS: Ohio County Solid Waste Authority c/o Rebecca Friend 176 Satterfield Drive Triadelphia, WV 26059
- Incomplete applications and/or late submittals will be disqualified.
- If USPS mailing, applicants have the responsibility of verifying the application has been received by the AWVSWA Scholarship Committee.
- Applicants submitting via email will receive a receipt confirmation from the AWVSWA.
- Illegible applications or applications without proper signatures will not be accepted.
