## Litter Control Officers

Officer Mitchell “Skee” Barley is a retired Captain of the Raleigh County Sheriff’s Office where he served for thirty years. He is also a combat veteran retired from the WV Army National Guard where he served twenty-one years and reached the rank of First Sergeant. Officer Barley is currently a Raleigh County Litter Control Officer who has investigated and aided in over 3000 cases in 8 years. Officer Barley advocates and was successful having a law passed which allows Litter Control Officers who are certified law enforcement officers, provided whose certifications are active, to have full law enforcement authority over litter crimes. Officer Barley continues working with legislators to ensure proposed bills pertaining to litter laws are fair, firm, and practical. To date Officer Barley has provided training for Litter Control officers from seven counties which includes Mercer, Wetzel, Lincoln, Harrison, Webster, Wyoming, and Wirt Counties; and also works closely with Litter Control officers in his neighboring counties.

Officer Barley was instrumental in helping First Sergeant Jim Mitchell of the West Virginia State Police establish L.E.A.F. Ministries, a ministry for law enforcement, by law enforcement where Officer Barley continues as a board member and chaplain. Officer Barley is a husband of 30 years to Teresa Barley and the father of 2 adult children, both of whom are nurses. Officer Barley is proud to be a lifelong resident of the great state of West Virginia and is a firm believer in the importance of litter control.
