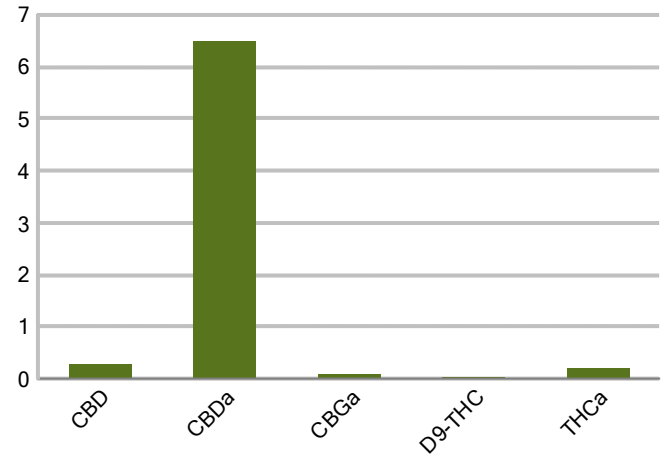

Cannabinoids (% weight)



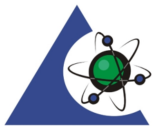

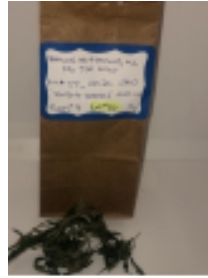
