August 28, 2025

- 1. Call Meeting to Order: The meeting was called to order at 4:11pm by Susan Sewell.
- 2. Pledge of Allegiance: All attending participated.
- 3. Roll Call: QFD: TC Collier, Travis Freedman, Phil Cushman (joined by cell at 6:24) MVFD: Pam Wolfe Brady, Susan Sewell, Teena Conrad, Judie New and Sam Rees. Dave Collier was absent.
- 4. Discussion Possible action: Approval of Minutes and Treasurer's Report:
 - QFD 7-22-25: TC Collier made a motion to approve the minutes and Treasurer's Report and the minutes from 7-22-25, Travis Freedman seconded and the motion carried unanimously by the quorum present.
