### **November 19, 2025**

1. Call Meeting to Order. **Called to order by chairperson Susan Sewell at 6:pm.**
2. Pledge of Allegiance. **All in attendance participated**
3. Roll Call. **Susan Sewell, TC Collier, Philip Cushman, Pam Wolfe-Brady and Travis Freedman were present. Will Aaron and Kevin Hess were the staff members present.**
4. Discussion and Possible Action re: Approval of Financials and Treasurer's Reports for the month of October. **Philip Cushman made a motion to approve the financials and Treasurer's report as presented. Pam Wolfe-Brady seconded and the motion carried unanimously.**
5. Discussion and Possible Action re: Minutes from October 24th meeting: **Susan Sewell made a motion to approve the minutes of 10-24-2025, Pam Wolfe-Brady seconded and the motion carried unanimously.**
