- 4. Call to the Public: None
- 5. Approval of the minutes of 8-15-2023: Candy Conley made a motion to approve the minutes aforementioned, Travis Freedman seconded and the motion was approved unanimously.
- 6. Old Business: Discussion & Possible Action: None
- 7. New Business: Discussion & Possible Action
 - 1. Accept the resignation of PSPRS local board chairman Dennis Dole. Will Aaron made a motion to accept the resignation of previous Chairman Dennis Dole, Riley Matzdorf f seconded and the motion carried, unanimously.
