Nisga'a Ts'amiks Community Meeting Minutes December 2, 2023

We acknowledge that we live and work on the unceded territory of the Musqueam, Squamish and Tsleil-Waututh peoples.

5. Administrative Reports:

a. Hoobiyee 2024

Q – Tania: I have some questions or suggestions as well regarding the vendors list. Will it be Nisga'a given priority first? That's my first question. The schedule, I know you did say that you're going to be addressing this at the debrief, but I don't know if this was addressed last year, I think the schedule we need, or you need to possibly think of a way to assert that that schedule is in stone or something because the issue that occurred last year happened right in front of Squamish Nation coming out and event or citizen was quite upset about the schedule change and had addressed one of your staff right in front of while they were coming out. It was actually quite embarrassing. Because cameras were on them and you could see the yelling, it ended up turning attention to those people and I felt bad for your staff member that had to deal with that. So, if there's a way to avoid having citizens approaching the staff or whoever's in charge of the scheduled changes, because we were on a time crunch that time. So that's one of the issues of security. If there's a way to possibly train a group of if you're wanting ambassadors, but maybe training a group of Nisga'as interested to get the security training that way. I'm not saying just volunteers, but that way it's not. A group of volunteers. You're having people that are actually trained.

A – Tony Robinson: First question, yes, vendors are going to be the priority. By your second question, we are looking at that. Thanks. Scheduling. It's going to be set in stone and it's

very important that you come to the meeting in December. So it's good to get your input in there and it will be set once the community finalizes scheduling. I like the Security question. We actually talked on the board level about it. And through Ts'amiks Development Corp.

- Q Kerry: I was wondering about how much tables are we allowed to use a table because I'm in peer support and we just give information about code then to get their booster shot. We don't talk about the testing part that much; we just get their booster shots and just your COVID shots. We know where the clinics are and stuff, and it's free and you just give your information out, not with like free of charge. And I was wondering if we're allowed to have the table just to give handouts. How much are they? How much do they cost?
- A Tony Robinson: We haven't determined the prices yet. Meeting is in December.
- Q Lily: Is there a list of how many dance groups have confirmed that they're coming and? So I was wondering if there's room for large dance groups to be invited. I just came across somebody who belongs to a Gitxsan dance group who would love to come for the first time. So well, is that list available or do I have to wait? I have one more question.
- A Tony Robinson: Thank you, Lily for now six confirmed. I believe we sent almost 20 invitations out. And it's not too late. I know. Gitxaala was mentioned earlier, so, you just have to get the contact details to me, and we'll see you.
- Q Lily: The last time the acoustics were not very good. You can't hear the dance group, the groups very well, especially if you're by the vendors you know, shopping at the vendors' table. You can hardly hear them at all. I hope that they have good acoustics this time.
- A Tony Robinson: We were informed of the sound issues. We're going to get our sound specialists to walk with us through the area.
- Q Sherry: Last year, I know this was already brought up, but I can't help but think about the teachings. Last year I attended a public meeting where the young people were identified to be lifted up and to do the drum drill. And they were the ones that were publicly pushed aside. And too many leaders over the front. So going forward, is this not something we're supposed to publicly apologize to these young people and we lift them up into the community for misunderstandings and don't use their gifts? The third purpose of that was to mentor them to become leaders. Just out of curiosity, is that something we're supposed to do as Nisga'a is to publicly apologize to young people for misunderstanding? Thank you.
- A Tony Robinson: I am in the process of meeting with Ts'amiks Dance Group Manager so whoever is on the dance group remind her to come and see me so that we can ensure the drum drill is in place on the first day. You can attend the Hoobiyee committee meeting in December. We can address all these issues.
- Q Sherry: As well as a board, we have talked about the apology. I did attend the Elders meeting on November 14th and I did see two of those dancers here. So I did get up and

apologized to them at the Elders' meeting and I stayed. I told them we didn't forget about the apology. I stated this in front of all of the Elders who were in the room at that time. Mine are more of like concerns about transparency regarding the coordination of everything volunteered to set up like help with these. The community has a lot of say in everything which it sounds like we didn't last year. So that was one of the biggest problems. And then also picking volunteers for the feast to set up the vendor group. We didn't have the time for that.

A – Tony Robinson: Thank you. Organization is critical. This is why we're having these meetings this year. This year we're looking to be more organized. We have a feast organization on January 6th. Voice your concerns at that meeting and we'll make sure everything is addressed.

Q – Dana: I just want to revisit the comments on security. I'm hoping that it might be possible for us to prioritize trauma and foreign leaders as well, those who are certified in mental health. And not only for Hoobiyee, but for all of our large community gatherings, because all circles of life come to these gatherings and rather than us, further escalate a situation. Someone sees it as a threat to kind of see the humanness of it. There was an incident even at our department community dinner. A few weeks ago, you know if we didn't have someone there who was trauma-informed, it could have been a completely different scenario. So again, revisiting common security to ensure that we always have someone who's certified in mental health and make that aware. For everyone in the room.

A – Tony Robinson: Good points and again, raise them at the next December meeting. We'll make sure there's a table of personal wellness.

b. Journey Home 2024

Q – Sherry: Thank you for your wonderful presentation and a really good reflection on the first one. My first question is about the spiritual aspect of the box. Have you connected with your department Elders', Council of Elders and Language and Cultural Director for guidance about that issue? It's pretty traumatizing issue. In regards to the communities, this is the most easiest time of the year for as I grew up in the village, for women and men who gather fish. What are their inputs into the Journey Home? Because when we did this, we started with them. About their availability and their agendas and how they saw fit to welcome people into their communities and into their families.

A – Shannon-Rose Vickers-King: The piece with the wood box that was this suggestion that came from board meetings and it's something that was felt very strongly that they really felt that it would be an amazing part of creating this Journey Home. It's in my plans to consult with counselors, with the IRS like that these different supports that are already in place for. I actually will ask you or contact you further for more information of who I could talk with at the Council of others because it is very important to me as well. I've reached out to the village governments and introduced myself and tried to make those initial contacts.

Q - Tania: I appreciate that you reached out to the community and considered our views. I suggested to the Nisga'a community to have a mini version of that here for the Nisga'a community in the city because when you take a look at the Downtown Eastside, and we have an outreach team that communicates with them. Many of our Nisga'a people that are lost down there are lost coming from residential school. And if you were to have those intimate conversations with them. They would find out that these were the reasons why they never returned home. I would really like to see some sort of forum because a lot of those people did not attend the last journey home. I would like to see some sort of forum or some sort of venue to open it up for them to be able to do, similar to what happened at the TRC event. Where they were given so many minutes to tell their story because we want to hear their story and that starts the healing because our community needs to start somewhere with the healing and many of those people aren't coming to these events because of that. It's not open to them yet. They're not feeling comfortable yet for a reason. And it's not pointing fingers at anybody. I would be willing to volunteer time if and should you do that as well, my question is, I mean, I didn't get to go the last time because of work. It was a very lengthy time process that I really wanted to attend but couldn't. We do have it on our travels to want to go home. To do any to do fish anyway, but in the event, we pay our own flights to go home, let's say just as an example, would there be the option of having a bus up there to be able to bring us to the Nas rather than that you know the extra cost of renting cars and such or whatever? Because I would really like to attend, but I just 12 days is quite lengthy to be away from here when you have a job and as well as we run our own business. So that's my question.

A - Tony Robinson: Thank you, Tania. And yes, we are ramping up our budgets. We are looking at the fast journey home budget. We did, we do have a \$180,000 budget right now and that's only for 75 members. And as soon as we get to that point, Shannon, myself, and finance, will sit down and go over all the transportation logistics. And we do want to make sure our Members are comfortable as well in that budget.

Q – Denise: I have a bunch of writing down ideas as they were coming. The first thing would be hotels. If you are able to get the government discount, we can book our clients at hotels. I also wanted to know this time if you'll have packages ready like paid for the elders or people so that they don't actually have a package in their hand. I also know that Holiday Inns have the First Nations discount and some salmons. Another suggestion going towards the leisure day. That makes it quite long, so I'd like to attend as well, but same with Tania. 12 days take off work is a little long. Ts'amiks could be a part of any of this event. I also wanted to suggest maybe if this is called the Journey Home and it's for them to go home to be able to meet their families and or learn about the cultural practices that were mentioned about harvesting, all those different things. Some of the people are going to go in yheir primary goal is to meet their family if they haven't, don't know them already. Or of they want to learn those cultural practices if the society needs to do it. Like say if we stop in Gitlaxt'aamiks, I don't have any family in Gitlaxt'aamiks. So if I was to go there with the entire group then that would be a full day where I'm just like waiting around.

A – Shannon-Rose Vickers-King: As this is very very introductory, this is kind of like a snapshot and it is really geared towards people who haven't really gotten to feel what it's

like to be home to feel that embraced in the community and also do the things that lots of us are very fortunate to have grown up being able to do. Building a connection ahead of time is really important because I heard it over and over again and the feedbacks a lot of people felt lost once they got there. I'm already kind of pulling together some ideas similar to what you're saying about looking at their family trees and making connections earlier connections with their groups so they kind of know what to expect before they get there. And I hear what you're saying about the different communities when I was there all my life I've never really known the other communities just locked up. It would be good to focus on and like there's things like leisure, if that's what you want to do then. You know, people would be able to go and do things on their own with their families and then, but also offering the different meaningful ways of connecting with our land and our people as well, but for that specifically, if you like that idea and I would like to look into that more with having certain things like the different traditional practices making the connections in each village for that. They can provide that to our people who desire to learn those things.

A - Tony Robinson: We are linked up with Indigenous Travel Services agency discounts on hotels, flights, and vehicle rentals.

Q – Lily: I was part of the Journey Home in 2011. It was a very healing journey for us. We went to Saint Michael's Residential School, it hadn't been demolished then. We all were so appreciative of having that opportunity to travel in memory of our mother as a child forced to go to that school. Are we remembering that? How they tried to steal her Nisga'a culture away from her? It is a part of our story and I think it should be documented. I really think we should hire writers that can document what happened. I think we should look back in 2011 and the mistakes that were made there. The next board of directors that elections in 2024 I don't want to see the next Board of Directors trying to hinder this project because from my understanding the video was made for 2011 almost got thrown in the garbage. there should be something in place to stop people that might try to hinder this project.

A – Tony Robinson: Thank you, Lily. As I mentioned earlier, we have grant writers, there are funding grants out there. We are looking to document this trip and have a book written on it. We're looking at writers for this. And I believe those 2011 CDs are still in the box.

6. Ts'amiks Development Corp.

Q – Tania: It's I think these are great initiatives. Sorry, I just have some questions regarding transparency, when was this board developed and how was the board, how was it opened? Board members join as a board of directors, who decided on the board members to look at the list. Is it not a conflict? I'm just asking the question because I do see it as a conflict. Correct me if I'm wrong. Where do the dollars come from? Is it just grants or is it streaming in from this? Business, government, and don't small businesses fall under these categories?

A - Tony Robinson: Thank you, Tania. As I went to an org chart, it's the NTVS Board is 100% owner of the TDC and TVC. In regards to conflict, I will leave that with the board to answer that one. The funding is not coming from grants. We could go after grants. But we had a

lucrative contract to start where we got almost \$1,000,000 from Arctic Construction and that's where the money came from.

- A Travis Angus: When we first started, we had selected and chosen our board. Our regular board as a stakeholder, you still have to have that input in there so that that transparency is still there. I don't see a conflict with it. But that's just in my own opinion. But everything's been working like I said we know everything that's going on here like there's we can hold both positions on our board here and I've got a list of people.
- Q Tania: Because there's two people on there, two of you that sit on the society, you're a board member. So what happens next year when, let's say you don't get back in? What happens to your position on the TDC? Do you still remain in those positions and who decided?
- A Travis Angus: Up to Nisga'a Ts'amiks in how they want to pursue if they want to appoint. You're looking at having somebody come on board for governance. That's a different story than trying to go into business. You need somebody with more of a business background than business mind.
- Q Greg: I was looking at your chart here. And it goes down to first work construction. And what do you mean by that? On your chart. Like you're hiring companies. Or I thought that's supposed to be hiring local. And I sent my resume here. And we never got a call back.
- A Tony Robinson: I am in contact constantly with Ascots in business relations person. If you can send me your resume, I will forward it. We are looking for a job fair as well. We have 5 partnerships, if we can get 20 in each contract, that is 100 employment for 100 Ts'amiks members.
- Q Carol: Speaking of transparency. A report of what grants were applied to. Was it successful? If not successful. Why? Keep saying there was grants applied to but no detail.
- A Tony Robinson: This is on the society side and what my finance accountant is here will provide a breakdown of all the funding grants that we've received. We'll discuss ore in this in the society meeting.
- ${\bf Q}$ Maureen: We see the benefits of the Development Corp. Will at any time there be opportunities to provide grants for home-based businesses of the citizens?
- A Tony Robinson: On the society side, contact Shannan Schimmelmann. There's a Ts'amiks Business Fund that's on our website.
- Q Sherry: This is the first I've heard of this presentation. I've seen corporations like this before where some of your Community Board Members are sitting on a business corporation and they talk about board, they're looked at as Community Board member, not as a Business Corporation Board member. So what is the liability of having that kind of stuff and I think what we would need. As a community, as a legal understanding how do we

ensure that both agencies are protected? Because when Travis, when you say as a board member and then you said the board member chose and I'm like which member chose? I'm not accusing you or anything, I'm just letting you know my confusion as an individual as well as a board member, not really understanding if we're 100% shareholder, that's different than being an administrator to your company.

A - Travis Angus: Just to be clear, I didn't start as a Board Member when this Development Corporation came into place, neither was Franklin. Prior to first term of office, Nisga'a Ts'amiks was the one that created the first board of the Development Corporation. So they were the ones that had picked and chose their board members. When we had chosen the board, we did approach a number of Nisga'a people that would sit on the board. And these were like people in the executive director positions or senior office positions that would help in that business realm, but it never fit their schedule. There was too much to take on because we're just starting out. It was like basically you're opening a book and trying to read together with it.

A – Andrea Burrell: It's the first term of TDC Board. Non-Nisga'a weren't seeing the same direction as Nisga'a members were on the board at that time. So all of NTVS Board members were in attendance at our board meeting when it was decided that we would put in place Franklin and Travis. Before everything happened, everything went to legal. The whole board was there at the meeting and everybody was under the same understanding. But you're right, this is the first time that this is being brought to the public.

A – Sherry Small: Please know that I trust the process, I parachuted into the Board. I didn't get an orientation. I appreciate the presentation. But I do see the confusion with this.

A – Travis Angus: I do want to apologize because I skipped a step on this. Because at our last AGM there was a request to come forward for TDC to come forward to do this process. So we had to get this done in order for it to fit us today. This is where we look at the ideas coming forward that we can bring into our strategic planning in those areas. We can separate the meetings off.

A - Tony Robinson: This is the complexity of the setup. It could get confusing. So what I'm going to do is I will work with our legal and accountants and develop a flow chart on this. But at the end of the day, we're all working towards the same values, and missions, and values. So that's my action item to develop a briefing note and I'll bring that to both sets of the boards before TDC's next presentation.

Q – Lily: I just wanted to address communication with the Board of Directors. I find it troublesome that one director is not fully informed about this. I think it's very important for board to work on communications in that regard. There's another board coming on. Hopefully, it's the same board members but If not, the next board is going to be they have the power to come in and fire everybody and make changes and that's what makes me nervous about this. I'm just wondering if the being on the board is a paid position. To be a board member, what do you have to have on your resume?

A – Tony Robinson: We did post when TDC first developed. There was a posting for Board of Directors. And we received about 8 applications that we brought to NTVS Board and this was back in 2021. It is paid as you've seen. Malcolm went over the financial statements, you'll see a line item in there. We hear your concerns. We were noting all your questions, I told the TDC board before we came here that all your questions and concerns are going to come up. We need to brainstorm how we can address all of your concerned areas.

Q – Carol: Can we see what is in the Economic Development program so far what is in the incubator for potential businesses on our Ts'amiks webpage? No names just a list.

A – Tony Robinson: Email Shannan Schimmelmann for further information about Economic Development: Shannan.s@tsamiks.com

Q – Greg: What I would like to know is what are the projections for this kind of project or housing for members of the NTVS and in the interim, what is Society or TDC doing about the housing shortage for members? I have the opportunity and have been lucky enough to stay with family and friends. When I was in Alberta, I was actually able to get my own place but now I'm back in BC. Again, I'm crashing on couches and I'm trying to get back on my own feet again.

A - Tony Robinson: On TDC side, there is a housing construction contract and if we find a project in the Lower Mainland, we can employ minimum 20 Ts'amiks members and that company will train members. In Society, the next community meeting will be held on February. And its agenda will be on Economic Development and Housing. For your concern, we are doing our due diligence on the housing referral partnership.

Q – Sarah: About Journey Home? What did they mean by going home?

A – Travis Angus: If you need to contact anybody regarding Journey Home, you can contact Shannon-Rose Vickers






Community Feast 2024 - Update







Q: WERE YOU A PARTICIPANT IN THE JOURNEY HOME 2011?




What kept the 4% from attending?

 This next section will focus on the 25% of survey respondents that went on the previous Journey Home.



STATS FROM THOSE WHO WENT ON THE PREVIOUS JOURNEY HOME:

Location:

- 49% lived in Vancouver at that time.
- 19% lived in the greater Vancouver areas like Burnaby, Surrey, and New Westminster.
- The remaining 32% lived on Vancouver Island and the interior of British Columbia.

Travel:

- We got responses from those that traveled by bus, bus/ferry, and their own personal vehicle, but no feedback about plane travel.
- The most favorable experiences came from those that traveled by bus and ferry.



Travel feedback:

One person noticed that some had their entire travel paid for while those who drove only received a travel subsidy.

Another person was disappointed that the travel option they would have preferred had a lot of people back out leaving many seats free.

Multiple people remembered the poor bathroom upkeep on the bus.

Planning considerations:

- Equal access for travel expenses.
- How can we support people to avoid no-shows?
- Consider hygiene if booking any longer travel options.




Accommodations during travel:

- 48% of respondents remembered their accommodations and Prince George had the worst experiences in the "not good" range.
- Some reflections to consider are:
 - Lack of communication about continental breakfast or no breakfast at all.
 - Booking the lowest quality rooms: "felt obvious that cheap was more important than comfort.

Accommodations in the Nass

- Most had no trouble, difficulties or serious situations. But issues for some included:
 - Shifty accommodations.
 - Having a teething baby, so opting to stay with family instead.
 - Sub-par sleeping arrangements.
 - For those who were reconnecting for the first time – events were too formal to "connect" and there was no way to go exploring when participants didn't know anyone.

Accommodations in the Nass continued:



Most (70%) arranged their accommodations in the Nass Valley themselves.

Planning considerations:





- Of the three 60's scoop survivors, one was not given access to a counsellor because they were for the "IRS survivors."


Current Journey Home Interest:




Organizational Chart - Corporate Structure


