## NOTICE IN ACCORDANCE WITH NISGA'A LAW

### Notice of Nomination Period For the November 6, 2024 Regular Election of of Nisga'a Government

Take note that the nomination period for the 2024 regular election of Nisga'a Government

- **begins at 9:00 AM on September 11, 2024; and**
- **closes at 5:00 PM on September 25, 2024**

During the nomination period, nominations may be made and filed with the Nisga'a Elections Officer for each of the following elected offices:

- President
- Chairperson
- Secretary-Treasurer
- Chairperson of the Council of Elders
- Chief Councillor for the Nisga'a Village Governments of:
  - Gitlaxt'aamiks
  - Gingolx
  - Laxgalts'ap
  - Gitwinksihlkw
- Village Councillors for the Nisga'a Village Governments of
  - Gitlaxt'aamiks – 7 (seven) to be elected
  - Gingolx – 5 (five) to be elected
  - Laxgalts'ap – 6 (six) to be elected
  - Gitwinksihlkw – 4 (four) to be elected
- Nisga'a Urban Local Representative for the
  - Greater Vancouver Urban Local – 2 (two) to be elected
  - Terrace Urban Local – 2 (two) to be elected
  - Prince Rupert/Port Edward Urban Local – 2 (two) to be elected

- ✓ A Nisga'a citizen listed on the Nisga'a Voters List as ordinarily residing in a Nisga'a Village may nominate or second the nomination of a person for the elected offices noted above for that Nisga'a Village Government.
- ✓ A Nisga'a citizen listed on the Nisga'a Voters List as ordinarily residing in a Nisga'a Urban Local Area may nominate or second the nomination of a person for the elected office of Nisga'a Urban Local Representative for that Nisga'a Urban Local.
- ✓ A Nisga'a citizen listed on the Nisga'a Voters List may nominate or second the nomination of a person for the elected offices of President, Chairperson, Secretary-Treasurer and Chairperson of the Council of Elders.
- ✓ Nominees for all elected offices must be Nisga'a citizens at least 18 years of age and not disqualified under section 15(2) of the Nisga'a *Elections Act*.
- ✓ Nominees for Chief Councillor or Village Councillor of a Nisga'a Village Government must ordinarily reside in the applicable Nisga'a Village.
- ✓ Nominees for a Nisga'a Urban Local Representative must ordinarily reside in the applicable Nisga'a Urban Local Area.
- ✓ Nominees for the offices of President, Chairperson, Secretary-Treasurer and Chairperson of the Council of Elders must reside within Nisga'a Lands or provide proof of a plan to relocate to Nisga'a Lands should they be elected.

Completed nomination packages can be hand delivered, sent via email or fax (with originals to follow in the mail) to the Nisga'a Elections office before 5:00 PM on September 25, 2024.

Please ensure that your nomination package contains all of the following:

- The nomination and acceptance forms
- A current criminal record check
- Payment of the nomination deposit of \$100.00 cash, money order or a certified cheque payable to the Nisga'a Nation

- Written certification from the Nisga'a Lisims Government Chief Financial Officer that the name of the person nominated was not included on the register of prescribed debts as of the date of nomination
