## NOTICE OF NOMINATION PERIOD For the By-Election of Non-NLG Directors, Nisga'a Ts'amiks Vancouver Society

In accordance with the Bylaws of the *Nisga'a Ts'amiks Vancouver Society* (the "Society"), and the *Nisga'a Elections Act* (the "Act") the nomination period for the 2021 by-election to fill two Board of Directors seats begins at **9:00 am on Wednesday June 23, 2021 and ends at 5:00 pm on Wednesday July 7, 2021**.

During this nomination period, a Nisga'a citizen may be nominated for one of the **two** (2) non-NLG directors of *the Society*.

**NOMINATION PACKAGES WILL BE AVAILABLE ON OR BEFORE June 23, 2021** at the Nisga'a Urban Local office, or by email upon request to esthera@nisgaaelections.ca or by phoning 1-866-633-2715.

Nomination qualifications are as follows:

- must be a general member of the Society, as defined in the Bylaws of the Society "as an
  individual enrolled under the Nisga'a Citizenship Act whose ordinary residence has been
  within the City of Vancouver for a period of at least ninety (90) days"
- must be nominated and have their nomination seconded by a Nisga'a citizen who is 18
  years of age and whose name is listed on the list of eligible voters,
- must meet all of the eligibility requirements that candidates for the office of Nisga'a
   Urban Local Representative from the Vancouver Nisga'a Urban Local are required to
   meet under the Nisga'a Elections Act, and

Before the close of the nomination period:

- the nominee will submit to the Nisga'a Elections Officer the required nomination and acceptance form, and
- a criminal record search report completed within four months of the date of nomination (or satisfactory evidence of having applied for one),
- written certification from the Chief Financial Officer of Nisga'a Lisims Government that
  the nominee's name was not included on the register of prescribed debts as of the date
  of nomination, and
- a nomination deposit of \$100 paid by the nominee in cash, money order or certified cheque.

The decision of the Nisga'a Elections Officer regarding the qualification of a nominee to stand for election to office as a non-NLG director of the Society is final and is not subject to any appeal.
