### **Charter History of ACBL's Ventura Unit, Unit 547**

Included in this file are photocopies of four (4) documents that granted the initial charter for Unit 547 in 1972, and also a single document that modified said charter (by expanding the geographical area) in 2003. Clarification of the 2003 modification was requested in 2008—details to be listed later in this paper. Neither Unit 532 (Southern Gold Coast, centered in Thousand Oaks) nor Unit 547 were completely satisfied with the new boundary line and in late 2014 a joint request to redraw the border was submitted to the ACBL. On January 20, 2015, ACBL granted the request. Again, details appear later in this paper.

#### Notes:

The cover letter issued in 1972 came from Greenwich, Conn., then the Headquarters of the ACBL.

The 1972 Ventura Unit Charter notes that the ACBL was incorporated in 1937 in the state of New York.

The first 1972 map, covering the state of California, shows Ventura (Unit 547), its western neighbor, Santa Barbara (Unit 542), and its southern neighbor, Oxnard, now renamed Southern Gold Coast (Unit 532).

The 2<sup>nd</sup> 1972 map, zooming in on Unit 547, the Ventura Unit, shows the geographical boundaries in greater detail.

The 2003 Charter update lists additional zip codes to be included in the Ventura Unit's geographical boundaries.

In 2008, Tom Ciacio, then the Manager of Unit-owned games, wrote to the ACBL asking for a complete definition of the Unit's boundaries. Patty Taylor responded with a list of Zip codes that comprise Unit 547. This list was the consecutive numbers running:

93001 - 93067

These Zip codes define a large geographic area, the northern portion of which is in the Los Padres National Forest. Concentrating on cities and towns, the area runs from Carpinteria east past Ojai to slightly beyond Fillmore and to the south to the Conejo Grade in Camarillo and then eastward along Highway 34 and the 118 Freeway to include Moorpark and Simi Valley.

In 2014, Units 532 (Southern Gold Coast) and 547 (Ventura) jointly submitted a letter (signed by the Presidents of each Unit) requesting redrawing the border between the two Units. If approved:

Camarillo Springs, Mission Oaks, and Camarillo would be officially part of Unit 547, Simi Valley, Moorpark, Piru, and Fillmore would officially be part of Unit 532.

A snippet from that letter gives the configuration of each Unit in terms of both cities/towns and zip codes:

This means the configuration of Unit 547 will now be:

Ventura (93001-09), Camarillo (93010-12), Carpinteria (93013-14), Oak View (Ojai area; 93022), Ojai (93023-24), Oxnard (93030-36), Port Hueneme (93041, 43, 44), Pt. Mugu (93042), Santa Paula (93060-61), Summerland (93067).

The configuration of Unit 532 will now be:

Thousand Oaks, Newbury Park, Fillmore (93015-16), Moorpark (93020-21), Piru (93040), Simi Valley (93062-65 plus 93094 and 93099), plus other communities which have been assigned to Unit 532.

On January 20, 2015, Cindy Wages of the ACBL staff responded as follows:

In the Spring of 2020 face-to-face bridge was shut down due to CoViD. For Unit 547 in-person bridge resumed in July of 2021. But before that happened, Unit 532 dissolved and its members were transferred into Unit 547. Many of those members lived closer to the San Fernando Valley Unit than to the city of Ventura and opted to transfer to Unit 561. Nonetheless, Unit 547's boundaries now include:

Thousand Oaks, Newbury Park, Fillmore (93015-16), Moorpark (93020-21), Piru (93040), Simi Valley (93062-65 plus 93094 and 93099)



Dear Ms. Wages:

Unit 547 and Unit 532 have identified certain towns and cities in Ventura County which are not really "connected" with the units to which they are assigned. An example is Simi Valley, a city which is roughly 20 miles from Ventura and assigned to Unit 547. Yet Unit 532's boundaries fall between the two cities. As a result, the two units have conducted a study of the zip codes assigned to Unit 547 according to the email from Patty Taylor at ACBL headquarters to Unit 547 Manager Tom Ciacio on December 11, 2008, with a copy to Cindy Wages. A copy of that email is attached.

Based on that study, Units 532 and 547 jointly propose that the following cities and towns (and zip codes) be moved **from** Unit 547 **to** Unit 532:

Fillmore (93015-16) Moorpark (93020-21) Piru (93040) Simi Valley (93062-65 plus 93094 and 93099)

Units 532 and 547 also jointly propose that the following cities and towns (and zip codes) be moved **from** Unit 532 **to** Unit 547:

Camarillo (93010-12)

This means the configuration of Unit 547 will now be:
