MINUTES OF ACBL UNIT 547 BOARD MEETING

- 1) Rose called the Zoom meeting to order at 10:30 am.

Per the advice of Charles, Dennis moved and Parker seconded that the club place \$33,000 in a one-year certificate of deposit at Bank One, our current bank. All voted in favor.
- 4) The club operations discussion was started by Rose, who noted the trouble getting enough players for limited games, in particular the 0-49'er on Tuesday. There is a move afoot to have 3 Districts pool players for 0-99er games and a night game at 7 pm. Our Club would receive a \$2.50 commission per player. The Saturday game has an adequate number of players. Larry move that we add limited master point games: Wed. 99'er, Fri. 299'er, Mon., Tues, Thurs., and Sat. there would be 499'er games. Mark seconded, all in favor. Larry moved that the cost of limited games be \$5. Parker seconded. Lorraine suggested \$4, but the motion by Larry was approved. The open games and 1499'er games will remain at \$6.
- 5) We agreed that our annual meeting be a virtual event. Board members made various suggestions to make the event special and well attended, such as it being a free game. See Rose's list that is at the end of the minutes.
- 6) Mark said that the nominating committee members are Kay Mendel and Tim Rea.
- 7) Regarding mentoring, Larry has updated the webpage to reach out to potential mentors. It is only a 4 hour a month commitment and done on BBO. Mark said that he is working with Raeann about virtual teaching.
- 8) Parker reported that his inventory at TBT and storage found nothing missing. Dennis will meet with Denise Cleric at the Camarillo Senior Center so do inventory on our metal storage cabinet at that location.
- 9) The next Board meeting will be November 12, 2020, at 10:30 am.
