Welcome to the Blackfeet Nation

Greetings!

We are the Blackfeet Revenue Department, which are a representative of the Blackfeet Tribe and the Blackfeet Nation. We would like to welcome you to the Blackfeet Reservation, we hope to be able to meet you face to face and answer any questions you may have. It is a pleasure to have your business accessible for our local consumers, we appreciate you.

As a reminder: *The Blackfeet Business Licensing Code is a part of Blackfeet Ordinance #86: Chapter II, Section I-III, pages 12-17 "Blackfeet Comprehensive Tax Code" was created by the Blackfeet Tribal Business Council and over time has been amended for the purpose of progress, since its origination.*

Blackfeet Resolution #88-2024 "Amending Ordinance #86 Updating Business License Fees and Revenue (2023)" This resolution was certified on October 26, 2023.

Our responsibility is to ensure that **ALL Businesses** are informed and accountable in following all written Ordinances and Resolutions for Licensure/Permits needed to conduct business within the exterior boundaries of the Blackfeet Reservation. It is **required** for any entity to purchase a business license/permit in order to conduct any type of business at any time. In addition to this, if any business entity plans on coming in to do any type of filming or photography for any type of public event or activity, you are **required** to purchase a filming permit, here at the Revenue Office prior to any filming or photography.

In addition, we are required to ensure that any and all businesses, whether they are local or outside businesses that they are following the proper steps prior to conducting business. There are several other key departments that they will need to contact, to ensure they are following their process as well. All of these tribal departments, including the Revenue Department play the role of protecting the Blackfeet Nation as a whole. We protect our Reservation boundaries, our lands, and everything on them. Most importantly, we are here to ensure that our people's health, safety and welfare are protected.
