## Canine Lounge Waiver and Liability

To be delivered to Canine Lounge with an original signature

1. All dogs enrolled at Canine Lounge must be at least 12 weeks old.
2. All puppies must have had their final vaccinations before attending Canine Lounge.
3. We recommend dogs over 7 months old to be neutered.
4. Proof of vaccination and sterilisation will be required.
5. At any time Canine Lounge may ask to see up to date vaccination records and exclude dogs whose vaccinations are not kept up to date.
6. Dogs must enter and leave Canine Lounge on a lead.
7. Owners must notify Canine Lounge if their dog becomes ill. Canine Lounge reserves the right to exclude any "at risk" dog and can request and a veterinary certificate prior to returning.
8. I agree to disclose any known aggression or other behavioural issues prior to enrolment.
9. I accept that pack dynamics can change over time and my dog may show a negative change in behaviour and may need to be excluded from day care, temporarily or permanently.
10. I accept that Canine Lounge's open environment can create risks including, but not limited to:
  - a. injuries including broken nails, abrasions, bites, cuts and sore pads
  - b. transfer of communicable illnesses such as kennel cough
  - c. behavioural problems
11. Payment must be made at arrival at or before each attendance.
12. Bookings are required and a "no show" will incur a charge of \$20.
13. All dogs are to be collected before the 6PM closing time. Late pickups will incur a late fee of \$15 for each 15 minute increment.

I agree that:

- a. I am solely responsible for any loss, damage or harm caused or contributed to by my dog while it attends Canine Lounge.

- b. If my dog becomes ill or if there is an emergency and I or my alternative contacts cannot be contacted, I authorise Canine Lounge to seek veterinary care for my dog.
- c. I am responsible for all costs associated with clauses a and b above.
- d. I will abide by all the rules specified in this Waiver and Liability form.

I release Canine Lounge and its employees and agents from all liability and indemnify Canine Lounge from any and all claims of every nature, arising directly or indirectly from my dog's participation in activities or use of service including legal claims.

I have read and understood this agreement and understand that I am waiving certain legal rights by signing and agreeing to this document.

I certify that:

- I am the legal owner of the dog or dogs I am sending to Canine Lounge.
- To my knowledge, my dog has not been exposed to communicable diseases within the last 30 days.
