- Treat everyone, including coaches, parents, skaters and officials, with respect, regardless of ability, age, race, creed, color, nationality or gender.
- Not engage in unsportsmanlike conduct.
- Not engage in rude behavior.

Medical Authorization

In the event of emergency, I understand that when medically feasible an effort will be made to contact a parent / guardian or emergency contact in the **Contact and Medical Information** section of this form. In the event that those persons cannot be reached or time does not permit, I hereby authorize medical treatment of skaters named on the **Member Registration** page of this form by licensed medical practitioners and/or emergency responders in connection with any injury resulting from, or any medical condition requiring emergent care occurring during any activity of Danbury Speedskating Club, including transportation to and from such activity. I also hereby assume the responsibility for payment of such treatment.

This medical authorization is effective for the time during which I and/or my child participates in the activities of Danbury Speedskating Club.

Liability Waiver

I understand that participating in the sport of speedskating involves risks to me and/or my child, including risks of serious injury, paralysis, permanent injury/disability or death. I voluntarily and knowingly recognize, accept, and assume this risk on my behalf and, as applicable, that of my child. In consideration of my (or my child's) access to and participation in the activities of the Danbury Speedskating Club (the "Club"), I, on behalf of myself, my child (if applicable), and any or all of my or our heirs, executors, representatives or other person(s) or entity(ies) acting on my or our behalf, hereby waive, release, remise and forever discharge the Club of and from any and all claims, actions, suits, demands, damages and liabilities of whatever kind which I or my child may have against the Club, the Danbury Ice Arena, or any of their officers, directors, employees, coaches, coach's designees, volunteers or sponsors, arising as a consequence of my or our participation in the activities of the Club. I further agree to indemnify, defend and hold harmless the Club, its officers, directors, employees and agents ("Club Indemnities") from and against any and all claims, demand, suits, actions, damages, losses or costs (including attorneys' fees and costs of suit) incurred by any Club Indemnities in seeking to defend or enforce the foregoing waiver.

Permission to Publish

I grant to Danbury Speedskating Club, the right to take photographs or video of me and/or my child during speedskating practices, events, and competitions. I authorize Danbury Speedskating Club, its assigns and transferees to use and publish the same in print and/or electronically.

I agree that Danbury Speedskating Club may use such photographs and videos of me and/or my child with first names only, and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.
