- d. Discussed ESD#3 applying for a matching grant for extrication tools. The grant has been applied for with LCRA and should hear within 8-10 weeks of the results.

- a. Discussion and action on ESD #3 Budget. Consensus is to keep the past budget to reflect 60% for Debt and 40% for Maintenance and Operation. All in agreement at this time.
- b. Discussion and action on adoption of the District's ad valorum tax rate of \$0.03 per #100 valuation for 2026 year and authorize the district's officers and officials to take all actions necessary to implement same. The motion made by Sawyer to adopt. A second by Hackworth.

The motion carried and is adopted. Proper notice will be prepared and placed in Llano News announcing a public hearing on September 8, 2025 at 6:00 pm meeting.

- c. Discussion and action on ordering an election in on the proposition of the increase jn the maximum tax rate of the district from \$0.03 per \$100 valuation to a maximum rate of \$0.10 per \$100 valuation and to authorize the district's officers and officials to take all actions necessary to conduct same. Motion to adopt by Hackworth. Second by Moore. The motion carried and is adopted.
- d. Discussion on the need for the treasurer to be bonded. Will address this next meeting in September.
- 8. Chief Gilliland gave his report on the LVFD. He would like to see a banquet for Llano Volunteer Fire Department to honor their work and dedication to city and community. More to come concerning this proposal.
- 9. Comments and discussion was held.
- 10. The meetings will be held each month on the 2nd Monday so next meeting set for September 8, 2025 at 6:00 pm. A motion to adjourn by Hackworth. Second by Tinsley. Motion carried and the meeting adjourned at 7:04 pm.
