CANCELLATIONS: \$30.00 admin fee plus an amount equal to the inspection fee for each inspection cancellation

REVIEW FEES: Are non-refundable

WORK STARTED

WITHOUT A PERMIT: In the event work is started prior to obtaining a permit application, a supplemental fee of \$50.00 will be added to the permit fee.

If violation is cited, or access is denied, a re-inspection fee shall be charged. All fees shall be paid prior to a Certificate of Occupancy

being issued

EXPIRED PERMITS: Permits that have expired after six (6) months will be re-issued at one half (1/2) the original permit fee if the amount is less than \$100.00

If the permit is great than \$100.00 a fee of \$50.00 or 10% of the original permit fee, whichever is greater, shall be paid prior to continuing

any work. A cancelled permit cannot be reinstated.
