**GENERAL** Electrical work shall not be started until the application for a permit has been filed with the electrical dept. Installation shall be in conformance with the state Electrical Code - No work shall be concealed until after inspection.

Refunds Requests for refunds must be made within one year of the date of issuance of a permit, subject to the following Cancellations \$30.00 admin fee plus an amount equal to the inspection fee for each insp prior to cancellation

Review fees Are non-refundable

Work started without a permit In the event work is started prior to obtaining approval of a permit application, a supplemental fee of \$50.00 will be added to the permit fee. If violation are cited or access is denied, a re-inspection fee shall be charged. All fees shall be paid prior to a Certificate of Occupancy being issued.

**Expired permits** Permits that have expired after six (6) months will be re-issued at one half (1/2) the original permit fee if the amount is less than \$ 100.00. If the permit fee is greater than \$ 100.00, a fee of \$ 50.00 or 10% of the original permit fee whichever is greater shall be paid prior to continuing any work. A cancelled permit can not be reinstated.
