The Charter Township of Raisin reserves the right to use an outside firm or agency to conduct plan reviews for the purpose of establishing code compliance. The applicant will be responsible for any fees charged by the firm or agency along with and administrative expenses incurred.	
<b>GENERAL:</b> Electrical work shall not be started until the application for a permit has been filed with the Electrical Department. Installation shall be in conformance with the State Electrical Code – No work shall be concealed until after inspection.	
<b>REFUNDS:</b>	Request for refunds must be made within one year of the date of issuance of a permit, subject to the following:
<b>CANCELLATIONS:</b>	\$30.00 admin fee plus an amount equal to the inspection fee for each inspection cancellation
<b>REVIEW FEES:</b>	Are non-refundable
<b>WORK STARTED</b>	
<b>WITHOUT A PERMIT:</b>	In the event work is started prior to obtaining a permit application, a supplemental fee of \$50.00 will be added to the permit fee. If violation is cited, or access is denied, a re-inspection fee shall be charged. All fees shall be paid prior to a Certificate of Occupancy being issued
<b>EXPIRED PERMITS:</b>	Permits that have expired after six (6) months will be re-issued at one half (1/2) the original permit fee if the amount is less than \$100.00. If the permit is great than \$100.00 a fee of \$50.00 or 10% of the original permit fee, whichever is greater, shall be paid prior to continuing any work. A cancelled permit cannot be reinstated.
<b>CONTRACTORS:</b>	Must show proof of State of Michigan license and register with the Charter Township of Raisin
<b>ALL FEES</b> 	<b>PURSUANT TO THE ABOVE SHALL BE PAID IN ADVANCE WHEN THE APPLICATION IS SUBMITTED TO THE CHARTER TOWNSHIP OF RAISIN</b>
