If violation are cited or access is denied, a re-inspection fee shall be charged. All fees shall be paid prior to a Certificate of Occupancy being issued. Permits that have expired after six (6) months will be re-issued at one half (1/2) the original permit fee **Expired permits** if the amount is less than \$ 100.00. If the permit fee is greater than \$ 100.00, a fee of \$ 50.00 or 10% of the original permit fee whichever is greater shall be paid prior to continuing any work.
