Witt, will try to have something by January, 2025. EGLE gave the Township \$400,000 for the Solar Project of Next ERA.

McNamara, provide Region II with the sliding scale <u>information</u>. Everyone comes with options to the January meeting to give to Region II. Redefine what is classified as an accessory building. Rise Over Run for the State of Michigan. Action item for January 14, 2025 meeting.

• Sign regulations and lumination – size and lighting

Witt, any type of lumination needs to come to the Planning Commission. Do we send out to OHM engineering firm? Needs to go to the Building Department to go to the Engineering Firm? 2. Discussion of Health Department Letter on Sutton Place II Site Condominiums

McNamara, this letter captures all the problems with this Site Plan. It is not common with the restrictions on the lots. This development is not going to be of the caliber that they are predicting. Restriction of drain fields on 3 lots, how enforceable is this? How do you regulate the number of occupants? Witt, this is a preliminary. The Board and Planning Commission will have to conduct another review had to review. Got the verbal that nothing has changed. We have another review of this Site Plan.

McNamara, the amount of restrictions on wells and septic fields and bedrooms on lots are concerning. We need a legal opinion on this project. Consumer Energy is not going to be liable for any damage. We haven't seen the Master Deed yet. Health Department only regulates the bedroom numbers not the number of occupants.

McNamara and Planning Commission Members acknowledge receipt of the Health Department letter with concern of restrictions. Planning Commission will wait until the application is resubmitted.
