

## MEDIA CONSENT FORM FOR YOUNG PEOPLE AND VULNERABLE ADULTS

## **Special Notice to professionals re. CIOC students:**

This consent form is to be used SOLELY for permission to take the young person's photograph (showing the student working and their work) for use in their daily Learning Record reports, which will be shared weekly with their commissioning school and relevant care/support professionals. These photographs will <u>not</u> be used in any other publications or shared on any other forums.

Any child under 16 needs to have parental/carer consent for having a photograph taken or being used, or for being filmed.

## MEDIA CONSENT FORM CONDITIONS OF USE

- 1. This form is valid for five years from the date you sign it, or for the period of time your child attends SKAPE. The consent will automatically expire after this time. However, you acknowledge and understand that there may still be materials in circulation after this time.
- 2. You are entitled to withdraw your consent at any time, provided that you tell us in writing.
- 3. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video, on our website, or in other printed publications.
- 4. If we use photographs of individual children, we will not use the full name of that child in the accompanying text or photo caption.
- 5. If we name (first name only) a child in the text, we will not use a photograph of that child to accompany the article.
- 6. We may use photographs or footage with very general labels, to identify the activity being carried out.
- 7. We will only use images of children who are suitably dressed, to reduce the risk of such images being used inappropriately.
- 8. Please note that websites can be viewed throughout the world and not just in the United Kingdom.
