2. Approve March 7, 2024, meeting minutes.

3. Chair Report, Green Ridgewood Activities since last meeting (David)

Sophia Florida will resign as of June 1st from Green Ridgewood as she is participating in an important internship.

Caitlin O'Leary is resigning at a TBD date.

Pam will follow up with the process to execute these resignations.

4. Village Council Liaison Report (Pam)

Ridgewood Living magazine contains an article about the Tree Shade commission and the "Adopt a Sapling" program. Another important article about the RHS Green club work. Green Ridgewood will be featured in a future issue.

The Shade Tree commission is running a "big tree" initiative. The biggest tree is on Hawthorne Ave., and everyone is encouraged to visit.

Asking the NJ legislature to allocate funds \$12M to help mitigate the cost of the PFOS facility development.

The Army Corp of Engineers met with the Village manager and talked about the flooding of the two rivers (HHKB and Saddle River), and they discussed a long-term approach as well as short term efforts including a detailed study of the problem. Their observation is to start both in tandem and the ACoE will come back to us with a set of recommendations (potential Forum to be held in June).

At the village council Slow Mow May was discussed, and it will be voted on April 10th.

- 5. Climate Fresk –Next Steps/Suggestions on Invitees (David)
 There will be another Climate Fresk on May 15th (tentative). Invitations will go out to department heads, village council, planning board and advisory committees, Ridgewood Water, etc. With the goal to also train 2-3 Green Ridgewood team members to continue the roll out in town in the Fall.
- 6. Collaboration with Columbia University: Status Report (David)
 - a. Project Status
 Pam and David went to Columbia University to attend one of their presentations. The students are finishing their research and are doing an internal presentation on April 17^{th.}
 - Expected Major Recommendations
 They have put together a series of recommendations around flooding, decarbonization and other important topics. They are creating a sustainability roadmap for the final presentation with some key focused proposals to VC.
 - c. May 1 Presentation to VC.
- 7. Bergen Hub and County Outreach –(David) Attended the Bergen County Commissioners meeting on March 20 and spoke during the public comments period.

 Request was made for elevated leadership by the County on a range of flooding issues that impact virtually every community in Bergen. Reaction was "tepid" from the commissioners. The Bergen Hub has established a Resilience/Climate subcommittee which David is chairing. Also, efforts made to connects with NJ Assemblywoman Lisa Swain (Chair of Appropriations Cmte.) to accelerate the focus on this topic.
- 8. School Activities/Sustainability Day Miles/Vivian/Sofia Sustainability activities: garbage audit by sorting through garbage post lunch. Sustainable Jersey approached the RHS GR to make a video and get \$2.5K. The main topics are trees and flooding.

April 19th Sustainability Day: large participation from students with multiple tables and topics. Pam and Yvone are attending.

There will be a second meeting on April 11th to go deeper into the ordinance draft that will also include the Village Manager and Mayor. This is an opportunity for Ridgewood to lead the way on the topic in the state of NJ and help address our flooding issues.
