Suggests to add this to required documents list on all applications At the very least, we should be requiring articles of incorporation or bylaws to determine the authority of persons applying. Discussion of cosigners/co-applicants; Co-borrowers/Co-signers, etc. must provide all the document requirement as primary borrower.
