## IX. Commission & Verbal Committee Reports

1) Commr. Calenda gave report of the HWCH remodeling committee. The foundation work required will cost about \$17,500.

Motion by Commr. Sinton to authorize the expenditure of up to \$20,000 from the HWCH reserve to provide an adequate foundation for the building, waiving review by the Finance Committee because this is an ongoing project of the commission paid for by designated reserves, and the work planned is essential to making the building safe for the future. 2<sup>nd</sup> by Vice Mayor Carroll.
