Note: DET's PoA guidelines are to ensure that kindergarten programs are available to those children who stand to benefit the most from attending early education. In mixed age groups, PoA guideline will equally prioritise three and four-year-old children that are considered high priority. Where programs for three-and four-year old children are provided separately, the PoA criteria will be applied separately for each age cohort.






Our Educators


Creative Minds Early Years provides a safe and nurturing space to children to explore through play.

Immunisation

The No Jab No Play legislation requires long daycare and kindergarten services to comply. To finalise your child's application to enrol, we are required a copy of the following:

Proof that your child's immunisations are up to date for their age.

Evidence of up-to-date immunisation must be provided within the two months before your child commencing at our service.

An immunisation history statement from the Australian Immunisation Register (AIR) is the only form of evidence that can be used to show your child's vaccinations are up to date for their age.

The quickest way to get your statement is by using your Medicare online account through **myGov** or the **Express Plus Medicare** mobile app. Alternatively, you can request an immunisation history statement in person at your local Medical service centre or call the AIR enquiries line on **1800 653 809** to request a statement is posted to you. It can take 14 days to get your statement in the post.

If you are short of time, you can ask your GP or immunisation nurse if they can print your child's immunisation history statement directly from the AIR. **Note**, not all immunisation providers can do this. If you are experiencing difficulties accessing vaccinations or required related documents, please contact us for assistance as soon as possible. In some cases, children can commence at the service while the required documents are obtained.

Advice for parents of children immunised overseas or not eligible for Medicare

The parent/carer can get overseas immunisations added to the AIR.

They need to take a translated copy of their child's overseas immunisation history to a general practitioner (GP) or immunisation nurse.

The GP or nurse will check which vaccines the child has had, and tell the parent/carer if any additional vaccines are required in Australia. They will record vaccines given overseas as well as any new vaccines they give the child on the AIR.

When the child's immunisations are registered on the AIR (this can take about five days), the parent/carer can ask the GP nurse if they can print an Immunisation History Statement from the AIR for the parent/carer to give to your childcare or kindergarten service.

Alternatively, the parent/carer can call the AIR on 1800 653 809 to check if the child's immunisations have been recorded and request a statement to be posted to the family. It can take up to 14 days to arrive by post.



Orientation Procedure

The time required for orientation and settling in will vary for each child and their family, therefore it is important to be flexible and individualise orientation for each family.

- Offer families the opportunity to visit the service at different times during the day/session, this allows the child and their family to become familiar with the various routines of the service
- Parents must stay with their child during orientation visit
- Provide reassurance to the family that they may stay with their child for as long as they choose once the child commences to build confidence in their new environment
- Provide the family with suggestions for developing and maintaining a routine for saying goodbye to their child
- Reassure the family:
 - they can leave their child initially for a shorter day, gradually increasing the length of time
 - they may call and speak to their child's early childhood teacher or educator(s) at an agreed time
 - the early childhood teacher/educators will keep them informed on how their child is settling in
 - they will be informed about any changes or circumstances which may affect them or their child.
- Further considerations may include but are not limited to:
 - send an email/or communication through Kidsoft iParent Portal during the day to update the family on their child including a photo of the child (if the child has settled in) (refer to the information and Communication Technology Policy). Note: For children in out-of-home care, the educator may need to seek permission from Child Protection before taking and distributing photos of the child
 - asking the family how they have settled in and if they have any questions or concerns.

Additional Support

Creative Minds Early Years supports inclusion of all children.

Support is available to plan and implement a program that is responsive to the individual abilities, interests and needs of children with a disability, developmental delay or complex medical needs.

Fee Payment and Centrelink

Kindergarten

Fees are payable per term (in advance) via direct debit. Refer to website for fees and due dates.

Invoices are sent via email and iParent Portal in advance of the fees due date.

Early Learning Centre

A Holding Fee is payable at the beginning of the enrolment. This is one week full fees, refunded when the enrolment is cancelled. Fee information is available on our website. Fees are invoiced fortnightly via email and iParent Portal and payments are direct debited.

Centrelink – Child Care Subsidy

To get Child Care Subsidy (CCS) you must:

- care for a child 13 or younger who's not attending secondary school, unless an exemption applies
- use an approved child care service
- be responsible for paying the child care fees
- meet residency and immunisation requirements.

Over Due Accounts

Fees that are not paid by due date in the first attempt will result in families being called to reschedule the payment. If the payment of fees does not go through the second time, families will be called to sign a Payment Plan Agreement as per Creative Minds Early Years Debit Management Policy.

A late fee of 15% per week is applied to any overdue fees.

Free Kindergarten

Kindergarten programs for four-year-old and eligible three-year-old children in Victorian Government funded services will be free as part of the Best Start, Best Life reform.

This investment will save families up to \$2,500 for each child enrolled in a participating sessional funded kindergarten (non CCS rebate) program. Children attending integrated funded kindergarten in long daycare (accessing CCS rebates) will save families up to \$2,000 for each child. Up to \$50 is deducted off fees weekly over 40 weeks.

DET also provides funding to assist eligible three-year-old Aboriginal and Torres Strait Islander children, and children known to Child Protection, to access kindergarten programs.





Early Start Kindergarten

* Early Start Kindergarten and Three-Year-Old Kindergarten

During the roll-out of Three-Year-Old Kindergarten, Early Start Kindergarten (ESK) will continue to provide 15 hours a week of funded kindergarten for all eligible children up until 2029, when three-year-old children across the state will have access to 15 hours

It is important to continue to enrol eligible children in ESK, even if funded Three-Year-Old Kindergarten is available at the service.

This guarantees that children experiencing vulnerability will continue to be enrolled in the full 15 hours of kindergarten in all service settings, including long day care. It also ensures that service providers can continue to receive all funding entitlements.

Service providers are expected to continue to provide the full 15 hours funded through Early Start Kindergarten, even in instances where three-year-old groups are being offered fewer than 15 hours.

ESK is available to children who turn three years of age by 30 April in the year of enrolment and who:

- are Aboriginal and/or Torres Strait Islander
- are known to Child Protection/Family Services/Orange Door
- have a refugee or asylum seeker background*

*Children/families without a current refugee visa or ImmiCard who have a recent refugee experience may be eligible by exception for Early Start Kindergarten, for more information contact your local Department of Education and Training office.

Cancelling Care or Changing Days

Creative Minds Early Years requires two full weeks written notice (an email will suffice) of an intention to change the days, providing there is availability, or the number of days required or to withdraw a child from Creative Minds Early Years.

The two weeks' notice begins from the close of business on the day Creative Minds Early Years receives the written advice. A request for additional days or a change of days is not confirmed until the service authorises this for the parent and is conditional in relation to the priority of access regulations.

Once two (2) weeks written notice of intention to withdraw the child has been received by Creative Minds Early Years, the advanced holding fee will be used for those two weeks. The Christmas closure period as advertised by Creative Minds Early Years (ELC only) cannot be included in a family's two (2) weeks' notice period for the withdrawal of a child from care.

Picking Up and Dropping Off your Child

For safety and security (and regulatory) reasons all children must be signed in on arrival and signed out on departure. The times must be noted.

No child will be allowed to leave with a person not named on the enrolment form, unless prior arrangements are made with the 2 staff members individually and person is over the age of 18 years..

Illness

In Victoria, primary schools and children's services, such as childcare centres and kindergartens, have a responsibility under the <u>Public Health and Wellbeing Regulations 2019</u> to exclude certain children for periods as specified in the regulations. There is also a responsibility to follow any direction to exclude a child that is made by the Chief Health Officer. If your school or service has a sick child, you must:

- ensure that unwell children do not attend your school or service, as per national guidelines (Staying healthy: preventing infectious diseases in early childhood education and care services, 5th edition)
- isolate children who became unwell during the day from other children and send the unwell child home as soon as possible
- exclude the unwell child
- if you are considering actions such as alerting parents, or displaying signage, call the department on 1300 651 160 who may give advice on whether such as action is required

Sick children need extra care and attention when they are unwell. Keeping them home to rest is important for recovery and will minimize the risk of transferring the illness to other children and educators.

Sun Protection

Creative Minds Early Years is a SunSmart centre.


Please abide by the following:

- Dress your child in clothes that cover as much skin as possible
- Singlets and shoe string straps t-shirts and dresses are not acceptable
- Sun protection is recommended when UV levels are 3 (Moderate) or higher
- Apply a generous amount of SPF30 (or higher) broad spectrum sunscreen prior to drop off
- Remember to pack child's hat and sunglasses. (Sunscreen if child has their own)
- Our policy is children cant go outside to play unless they wear a hat (wide brim or legionnaire hat or bucket hat), appropriate clothing & sunscreen
- If children do not have appropriate hats or outdoor clothing they are asked to play in a shady space or a suitable area protected from the sun
- Too much unprotected exposure to the suns ultraviolet (UV) rays can cause skin damage, eye damage, immune system suppression and skin cancer

Sleep and Rest

Creative Minds Early Years is committed to:

- providing a positive and nurturing environment for all children attending the service
- recognising that children have different requirements for relaxation and sleep, and being responsive to those needs to ensure that children feel safe and secure at the service
- consulting with parents/guardians about their child's individual relaxation and sleep requirements/practices and ensuring practices at the service are responsive to the values and cultural beliefs of each family
- its duty of care (refer to Definitions) to all children at Creative Minds Early Years, and ensuring that adequate supervision (refer to Definitions) is maintained while children are sleeping, resting, or relaxing
- complying with all legislative requirements, standards and current best practice and guidelines, including recommendations by Red Nose

Food

Creative Minds Early Years promotes healthy eating habits and nutritional lunchboxes for the children.

Families are required to bring their own packed breakfast, lunch and snacks (including water).

Enough food for the day in preferably environmentally friendly packaging.

Children are often more hungry and active while in care.





Hygiene Procedures

The implementation of appropriate hygiene and infection control procedures aims to break the cycle and prevent the spread of infections at every stage. The National Health and Medical Research Council (NHMRC) suggest that to reduce illness in education and care services, the three most effective methods of infection control are:

- effective hand washing
- exclusion of sick children, staff and visitors
- Immunisation

Other strategies to prevent infection include:

- cough etiquette
- appropriate use of gloves
- effective cleaning of the service environment





Child Protection

Creative Minds Early Years supports each child's right to live and learn in a safe and secure environment.

As mandatory reporters, employees are required to report and act in accordance with the procedures for recognising, responding to and reporting child abuse and neglect to the VIC Police and Child Protection.







Late Collection or Failure to Collect

Arriving late to collect a child is not acceptable behaviour, as this means we are operating outside the licensing hours and your place may be at risk if this behaviour is continued. A minimum of 2 staff members must stay behind until the parent (or their nominated emergency contact) is able to collect the child.

A late fee (for any reason) of \$2 per minute in 15-minute minimum blocks by Creative Minds Early Years for each child will be charged for any child collected later than Creative Minds Early Years closing time.

Absences And Holidays

Normal fees apply to sick days, family holidays and any other absence. Long Daycare fees are not charged for days when Creative Minds Early Years is closed, such as start and end of year set up & pack up days and any group Professional Development Days.

All public holidays will be fee free days (Long Daycare only) for all families booked into the service for that day. Please note Creative Minds Early Years does not operate on Public Holidays. Refunds are not applied for these days.



Emergencies

Emergency evacuation drill every 12 weeks

- Emergency (eg. Fire)
- Medical emergency
- Lock downs
- Offsite evacuation

Creative Minds Early Years is listed on the Department of Education Risk of Grassfire (category 4). We are **not** allowed to open on Victorian Emergency Management - Catastrophic Fire Danger rating days.

Security

Creative Minds Early Years has security cameras installed to protect the premises after hours.

The security is not recording while children are present

in the building.

Security is turned on at 6.15pm and turned off at 6.30am.
