CASA, which stands for Court Appointed Special Advocates, trains volunteers to advocate for the best interests of children in foster care and abuse and neglect cases. Our volunteers provide a consistent and caring voice for children during difficult times, ensuring their needs are represented both in and out of the courtroom. This critical service is unique to our area, and no other organization provides this level of advocacy for children in our community.

The need for our services continues to grow. In 2025, Southeast CASA had the privilege of advocating for 53 children across 39 abuse and neglect cases in Yankton, Bon Homme, Clay, Turner, and Union Counties. Through the dedication of our volunteers, children are given support, stability, and hope while navigating challenging circumstances.
