The Buyer agrees to take the puppy to see a veterinarian of their choice within 72 hours of delivery. Should the puppy be found to have a minor pre-existing condition, within the 72 hours, Front Range Goldendoodles will be responsible for up to \$100 of treatment or medication. If the veterinarian finds any preexisting serious or life threatening problem the Buyer may return the dog to Front Range Goldendoodles within 48 hours of the exam for a full refund of the original purchase price. Buyer understands that minor imperfections such as malocclusions (bites), undescended testicles, umbilical hernias and other cosmetic issues are not covered in this guarantee.

This document also serves as a 2 year genetic health guarantee that the puppy will be free of the following inheritable genetic defects seriously affecting the quality of life.

Hip Displasia

Von Willebrand's Disease

Progressive Rod-Cone Degeneration

GR PRA2

NEwS-Neonatal Encephalopathy

Should the puppy be diagnosed with any of the stated genetic problems before they are 24 months of age, Front Range Goldendoodles will reimburse the buyer for vet prescribed treatment expenses up to the original purchase price of the puppy. All testing and examinations are the responsibility of the buyer. A licensed veterinarian must provide proof that the genetic defect exists and that there has been no apparent accidents and the dog is in otherwise good health.

Buyer agrees not to take the puppy to public places unless reasonable precautions are used to prevent exposure to contagious disease, and not to socialize the puppy with unvaccinated dogs until a minimum of 10 days from the date of the final set of puppy shots.

Buyer agrees to maintain the puppy at a healthy weight, keep the puppy up to date on all vaccinations and preventative care, not over exercise the dog in the first year and spay or neuter the dog by 7 months. Any failure to do the above will render the health guarantee null and void. Proof of spay or neuter is required to be sent to the Seller within 30 days of the procedure or the health guarantee becomes void. Breeding this puppy without breeding rights under a separate contract is prohibited. Should the Buyer breed the dog or refuse to show proof of spay/neuter, repossession of the dog may result and the buyer will be responsible for all expenses incurred, including legal fees from the repossession.

Buyer understands the puppy is not guaranteed to be hypoallergenic or low shedding and that no guarantee is made on size, color or coat.

Buyer agrees to notify Front Range Goldendoodles first if it becomes necessary to re-home the dog at any point and recognizes that this guarantee is non-transferable.
