## 2. Fees/Compensation/Materials:

(a) Tuition shall be calculated at a rate of \_\_\_\_\_\_\_(\$) dollars per hour of tutoring. No further fees shall be charged for traveling (to the specified Location) or preparation time of the Tutor. Tuition rates may be adjusted from time-to-time and shall become effective after having given the Student seven (7) days written notice. When Tutor is required to travel to any address **outside of the specified Location**, the standard fee of \$\_\_\_\_\_\_/hr shall include travel time to and from Location. A fee of \$5 per every 15 minutes of travel of Tutor (rounded up, one-way) will be added to the total fee.

**(b)** In some cases, extra materials may be required for certain types of lessons. If extra materials such as workbooks, manipulatives or books specific to the Student's school are necessary, the Student/Parent shall incur all costs for such materials. Consequently those materials will be considered the Student/Parent's property, and will remain the Student/Parent's property after tutoring lessons are completed. Any materials purchased by the Tutor shall be considered the Tutor's property, and will remain the Tutor's property after lessons are completed.

Special situations will be assessed as needed.

# III. Scheduling

### 1. Cancellations:

- (a) Cancellations by the student/parent must be given to the Tutor at least 24 hours in advance. If the Student/Parent does not give 24 hours notice, the Student/Parent will be charged for the full amount of time scheduled.
- **(b)** The Tutor may cancel lessons by giving 24 hours prior notice to the Student/Parent in which case no fees shall be incurred. In the case that a lesson was pre-paid, the Tutor shall reschedule the appointment at a time agreeable to both parties. If, for some reason, the lesson cannot be rescheduled during the same week, the Tutor and Student/Parent will agree to either
  - (1) have the pre-paid portion of the tuition refunded, or
  - (2) apply the pre-paid portion of the tuition toward another future lesson.

### 2. Late Arrivals:

- (a) Fees are calculated according to the times stipulated in the schedule and no adjustment shall be made for time lost because of late arrival by the Student. In addition, students picked up late on more than one occasion will be subject to additional fees equal to \( \frac{1}{4} \) of the hourly rate for each 15-minute period.
- **(b)** Any lost time because of the late arrival of the Tutor shall be compensated for by extending a lesson by the amount of time that is lost. If the Tutor or Student/Parent is unable to have the lesson extended, the Tutor shall subtract the time she is late from the owed tuition. In the case that a lesson is pre-paid, the Tutor and Student/Parent will agree to either:

(2) apply the pre-paid portion of the tuition toward another future lesson.

## 3. Rescheduling:

(a) The Student/Parent may be able to reschedule a lesson in lieu of cancelling when 24- hours notice is not given to the Tutor. Rescheduling must be agreeable to both parties. If the Tutor is unable to accommodate the Student/Parent with a rescheduled lesson, the Student/Parent is still responsible for payment of the cancelled lesson. If the Tutor is able to accommodate the rescheduled lesson, the same cancellation rules apply to the newly scheduled lesson as stated above. The rescheduled lesson must be for at least the same amount of time as the regularly scheduled lesson. If it is shorter, the full amount of the original lesson will be charged.

### 4. No-Shows:

(a) No-shows include lessons in which the Student does not show up to his or her lesson with no notice at all to the tutor (text, email, etc.). Tutor shall **wait at least 15 minutes** before marking a student at a No-Show. No-shows will be treated as "cancelled lessons" in regards to payment, and a student who has more than (3) No-Shows will be subject to termination of any further tutoring lessons in the future.

# IV. Obligations

#### 7. The Tutor shall:

- A. Structure each session optimize time to benefit the student
- B. Keep the student's information confidential, with the exception of the parent or guardian listed in the contract. The tutor will only contact outside parties if given written permission to do so.
- C. Not assign duties or obligations under this contract to a third party without the permission of the tutor.
- D. At any time be required or obligated to provide homework or assignments on behalf of the student.
- E. Attend all scheduled tutoring sessions and arrive on time.
- F. Contact the student/parent no less than 24-hours in advance should a session need to be rescheduled or cancelled.
- G. Wait at least 15 minutes before marking a student as a "No-Show."

### 8. The Student/Parent (if student is a minor) shall:

- A. Attend all scheduled tutoring sessions and arrive on time.
- B. Contact the Tutor no less than 24 hours in advance to cancel or reschedule a session.
- C. Bring all assignments, textbooks, notes, homework, and any other necessary materials to the tutoring session; share that information with the tutor.
- D. Actively participate during the tutoring session by doing the following: asking questions, engaging in dialogue, taking notes, and completing all assignments.
- E. Bring tutoring notebook, folder, and complete extra practice, if provided, assigned by the Tutor.

### If the student is a minor:

A. The parent must remain in the building while the Tutor and student are working together unless consent is provided. Permission can be provided below:
