- Lights at CF: Michele has multiple options. She is waiting for the new townhomes area layout to make a final decision. Dave explained to her that the new homes were far away from courts and that lights should not be an issue
- Web Cams at CF: Michelle will review this with the board to see if they are allowed.
- Court Maintenance Concerns: Power washing will be done multiple times a year, but Michelle did not have dates. Sanitizer will be refilled at FC courts. Michelle has agreed to buy a blower and chest to store them in for FC and CF courts. We will be responsible for them.
- Basketball Hoop Relocation: There are no plans to move the basketball court.
- Michelle will discuss with the board whether swipe cards will be approved for CF.
- Dogs on the courts: Dave requested that they update FC rules to indicate "no dogs within the enclosed area".
- Parking at CF: Michelle was not aware of a parking issue. Dave recommended they get in touch with new owners to discuss parking.
- Court Reservation: Only two courts can be reserved at a time. Park Landings' 4-court reservation has been a long established group, but moving forward the FC will not allow any group to reserve four courts on a permanent basis.
