

BFPC BOD Meeting Minutes

June 30, 2026

1. Approval of minutes from May 26, 2026, KL approved; SG seconded
2. **Membership Update & Communications**; KL: 477 members as of 6/29/26. Visual signage will be upped for future events ie...postings will be on court gates as well as bulletin/message boards. Concerns were mentioned that messages/club information may be getting buried /junked in members' emails and therefore missing out on club information. This is our attempt to continue to reach as many members as possible.
3. **Treasury Report**; AC: Ending balance for June is \$10,841 which reflects the \$231 for the June Father's Day event. We received a donation check from Brunswick Water Filters for \$500 that will be deposited next week. This will be reflected in July financials.
4. **Maintenance**; DS: FC Tennis/PB courts are being repaired in the fall. We are running low on balls and will continue to use/purchase Franklin X balls. \$55 for misc supplies was approved. DS suggested adding rubber protective pieces under the portable net at the FC. This will help protect the court's surfaces. It was approved.
5. **Programs**; SG/TT: SG will contact Laurie D about training sessions in the fall. Round Robin will begin 9/8/26, and Skatter Days will begin 9/12/26.
6. **Vice President**; WR: Father's Day event had all positive feedback and was well attended. Pretzels may not be the way to go next year. Suggestions were subs, hot dogs, or pizza? Approx cost was \$225. The HOP event save-the-date went out. 8/22 6-9:30 with a DJ for 3 hours. Volunteers are needed. We will use

the HOPS new paddle stacking system. We will not have the King of the Court challenge this year. We will be giving out BFPC “swag” as random door prizes. Holiday Party music? DJ vs Band? Juno? Other bands? We need to update the playlist and check pricing for the bands. Some of the bands we might be interested in are playing locally. Some board members will go listen and report back. If we have a band, will this tweak the interest to attract more members to attend? Should we change the food?

7. **President**: ALC: Succession Planning. We are currently looking for ideas/names for new board members for 2027. WR will be moving to President. We will have 4 positions open. TT and WR will reach out to a few people to check for interest. WR will attend the CAMs meeting in July with ALC. ALC made mentioned as a housekeeping item that it’s good discipline to mention/ask ahead of time before acting on club's behalf. The BOD needs to have knowledge of all things done/represented by the BOD.

8. **Other Business**: Keith Murray from Brunswick Water Filters attended the meeting as a potential sponsor for our August event at the HOP. He would like to give \$500 to the general cost of the event. In return, He would like to be mentioned in the initial email blast, introduction at the beginning of the event and a possible shout-out now again throughout the event. He will also be providing 6/10 giveaways. BFPC will not be endorsing this business, and wording will reflect that on any signage. Keith will provide wording/signage for our communication. 100% by BOD and check was given to AC.
