

BFPC BOD Meeting Minutes

April 21, 2026

Meeting start: 1:30 pm; meeting adjourned 2:36 pm

All 7 board members are in attendance.

1. Approval of minutes from March 31, 2026; KL approved; WR seconded
2. **Membership Update & Communications**; KL: Current list shows 437 members. Programs should handle Mom and Dad's event communications.
3. **Treasury Report**; AC: We will have a few very small expenses for I/C, RR and Shark Barracuda snacks. We have budgeted \$250-\$500 per event...excluding the Holiday party. Ending the month at approx \$11,000. PayPal is in line with membership numbers.
4. **Maintenance**; DS: The main gate at the FC has been repaired however; people can still put an arm in to open the gate. ALC will bring it up at her meeting with CAMS.
5. **Programs**; TT: Shark/Barracuda challenge will be on April 24th. 10 teams will participate. The club will purchase refreshments for the players. SG and TT will declutter Go Daddy and Sign-up by removing old dates and messages from prior years. Only a few weeks left of RR and SKD. SG asked if BFPC would offer one membership as a donation. It was voted down. SG is currently the captain of the social intercommunity team. He is requesting to recruit an additional captain for the fall season. TT suggests having a large info meeting in the fall for all interested intercommunity players. Give out all the information, in person, in lieu of email messages.
6. **Vice President**; WR: Dinko DeMayo have 54 signed up so far. BOD will be needed to volunteer. We will be using bracelets to sign in. Laurie D. will not be available for paddle demo. Waiting for a response from Kim M. Muffins for Moms

is a go for May 9th. TT will send out email communications and sign-up info. If you sign-up, please show up. We will allow 25 to sign up for each level. Father's Day event will be June 19 5-7:30. Beer and Pretzels. 2 beers/pp. Round robin format. Sign up will be in the same format at Moms event.

7. **President**: ALC: 2 emergencies at CFN in April. 2 new first-aid kits were purchased by CAMs...1 for each court. DS secured/installed at each court. A box of ice packs was purchased and put at CFN. Tiffany (CAMS) will be making up an address plaque to be installed at CFN courts for ambulance to find the courts easier. ALC reminded that court reservations go through the main fitness center offices and not through the club...as this was a question brought up in a member email. Tournament in Carey will be tabled until next year. ALC may be back to facilitate this next year. Painting of the posts (not the courts) at the FC will be at the end of April. The message board for the FC courts is no longer accessible as the main entrance is not a locked gate. Can we get this moved?

8. **Other Business**: next CAMs meeting is April 29th. The club does not want to promote member pickleball related businesses. A member is more than welcome to post individual pickleball related business on the FB page, but we will not endorse. The succession plan for 2027 will be discussed at the May meeting.
