APRIL 24 MEETING

The April 24, 2001 Meeting will again be held in a different location due to more renovations going on at St. Pius K. of C. (our regular meeting location).

At the April meeting we will be having a 'how to rig' seminar with a boat on display. This is an opportunity for those of you needing new or additional information on rigging your boat for fishing Great Lakes Trout and Salmon.

We will also have a round table discussion with some of our top Skippers from 2000 speaking and taking your questions on what made their 2000 season a success. There will be a lot of good 'how to' information given for our upcoming boat tournaments. If you plan to fish Lexington, St Joe, etc. then plan to attend this meeting.

RIVER CRAB TOURNEY

This year's River Crab Salmon Stakes Tournament and raffle featuring the return of Slippery Charlie takes place on April 28. This will also be the first DAS tournament of the 2001 season.

The Bluewater Mental Health and Child Guidance Clinic of Port Huron and the C.A. Muer Corporation (River Crab Restaurant) are co-sponsors of the tournament. Proceeds are donated to the Blue Water Clinic and seven other child abuse/neglect agencies throughout Michigan.

Again this year, there is a \$5,000 prize for the club with the heaviest catch. The Board of Directors would like to see all of our club members try to participate in this tournament.

Tournament Chairman Mark Stosiak has announced that the DAS Board has approved a special incentive for our club participants. IF the DAS wins the \$5,000 club prize we will have a special drawing among all of the boats who weighed in at least one legal fish. One Boat will win \$1,000, one will win \$500 and one \$250. In addition, there will be a drawing for \$100 for a boat that participated, that did not weigh in a fish. If we don't win the \$5,000 club prize, one boat that weighed in a fish will be drawn for \$100.

Let's make this tournament the number one tournament on your schedule and help the club win the \$5,000 and some skipper \$1,000.
